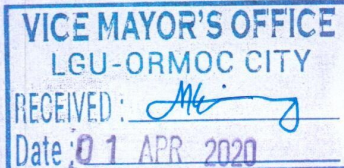

ADOPTED, March 31, 2020.




