A RESOLUTION AUTHORIZING THE RELEASE OF PAYMENT OF MAGNA CARTA BENEFITS OF MRS. WELMA P. LAURENTE AND MS. VILMA F. MENDOZA, DETAILED REGULAR EMPLOYEES AT THE CITY HEALTH DEPARTMENT TO BE CHARGED AGAINST CURRENT YEAR'S PERSONAL SERVICES (PS) APPROPRIATION OF THE SAID OFFICE.

WHEREAS, the Sangguniang Panlungsod was in receipt of an Indorsement Letter from the City Mayor's Office (CMO), relative to the request for the issuance of resolution authorizing the release of the payment of Magna Carta Benefits of Mrs. Welma P. Laurente and Ms. Vilma F. Mendoza, detailed regular employees at the City Health Department to be charged against Current Year's Personnel Services appropriation of the said office;

WHEREAS, Republic Act (RA) No. 7305, otherwise known as The Magna Carta of Public Health Workers was signed into law in order to promote the social and economic well-being of health workers, their living and working conditions and terms of employment, to develop their skills and capabilities to be better equipped to deliver health projects and programs, and to encourage those with proper qualifications and excellent abilities to join and remain in government service;

WHEREAS, Section 20 of The Magna Carta of Public Health Worker provides for the Public Health workers to receive the following allowances: hazard allowance, subsistence allowance, longevity pay, laundry allowance and remote assignment allowance;

WHEREAS, the Department of Budget and Management and Department of Health (DBM-DOH) issued a Joint Circular No. 1 entitled "Rules and Regulations on the Grant of Compensation Related Magna Carta Benefits to Public Health Workers" dated November 29, 2012 as amended by DBM-DOH Joint Circular No. 1 dated July 15, 2016 providing for the governing guidelines of payment of the aforementioned benefits;

WHEREAS, the Ormoc City Health Officer reported last January 30, 2020 in a letter to the City Mayor that Mrs. Welma P. Laurente and Ms. Vilma F. Mendoza, Ormoc City Health Department detailed employees failed to receive their Hazard Pay and other Magna Carta Benefits due to the late submission of their December 2019 payroll and hence requested for their Hazard Pay Claims and Magna Carta Benefits to be charged against the Current Year's PS of their office to which aforementioned letter is hereto attached as Annex "A";

WHEREAS, the City Budget Officer, City Planning and Development Coordinator, City Accountant and City Treasurer issued a Certificate of Availability Funds dated March 11, 2020 stating therein that the amount of Nine Thousand Four Hundred Sixty Philippine Pesos (Php 9,460.00) is deemed available for the payment of the Hazard Pay and Magna Carta Benefits of two (2) detailed regular employees, hereto attached as Annex "B" and made integral part hereof;

WHEREAS, this Sanggunian authorizes the City Treasurer to release the payment of Magna Carta Benefits of Mrs. Welma P. Laurente And Ms. Vilma F. Mendoza amounting to Nine Thousand Four Hundred Sixty Philippine Pesos (Php 9,460.00) as computed following the guidelines set by DBM-DOH Joint Circular No. 1 entitled "Rules and Regulations on the Grant of Compensation Related Magna Carta Benefits to Public Health Workers;
