A RESOLUTION ALLOWING THE CITY ACCOUNTANT TO CHARGE THE CASH INCENTIVES FOR THE ATHLETES OF SOUTHEAST ASIAN GAMES 2019 IN THE AMOUNT ONE HUNDRED SEVENTY-FIVE **THOUSAND** PHILIPPINE PESOS (PHP175,000.00) AND PALARONG PAMBANSA 2019 AMOUNTED TO TWELVE THOUSAND FIVE HUNDRED PHILIPPINE PESOS (PHP12,500.00) WITH THE TOTAL AMOUNT OF ONE HUNDRED EIGHTY-SEVEN **THOUSAND** FIVE HUNDRED PHILIPPINE PESOS (PHP187,500.00) AGAINST THE CURRENT YEAR'S **MAINTENANCE** AND **OTHER** OPERATING EXPENSES MOOE APPROPRIATION.

WHEREAS, the Office of the City Mayor forwarded an Indorsement Letter dated March 24, 2020 to this Sanggunian for consideration, relative to the request for a resolution authorizing the release of the cash incentives for the athletes of Southeast Asian Games 2019 in the amount of One Hundred Seventy-Five Thousand Philippine Pesos (Php175,000.00) and Palarong Pambansa 2019 amounted to Twelve Thousand Five Hundred Philippine Pesos (PHP12,500.00) with the total amount of One Hundred Eighty-Seven Thousand Five Hundred Philippine Pesos (Php187,500.00);

WHEREAS, this Sanggunian approved last Dec 10, 2019 Ordinance No. 014 (Series of 2019), "AN ORDINANCE AMENDING ORDINANCE NO. 056, S. 2018, ENTITLED: "AN ORDINANCE GRANTING CASH INCENTIVES TO ATHLETES AND COACHES IN ORMOC CITY INDIVIDUALS, PAIRED, OR GROUPS WHO EXCELLED IN SPORTS COMPETITIONS AND APPROPRIATING FUNDS THEREFORE";"

WHEREAS, Section 2 of the said Ordinance No. 014 (Series of 2019) provided for the new amount of incentives to be given to qualified athletes and coaches;

WHEREAS, Section 3 of the same provided for the retroactivity of the provisions to include Nationals and International competitions held within the last quarter of 2019;

WHEREAS, the Southeast Asian Games 2019 was held last December 5 to December 7, 2019;

WHEREAS, the cash incentives incurred in the year 2019 but was left unpaid because of the lapse of the deadline for the submission of documents and the closing of the books of the City Accounting Office;

WHEREAS, the City Budget Officer, the City Treasurer and the City Accountant, through a certification dated March 24, 2020, certified that the amount of One Hundred Eighty-Seven Thousand Five Hundred Philippine Pesos (Php187,500.00) for payment of the aforementioned cash incentives is deemed available to be charged against Current Year's Maintenance and Other Operating Expenses (MOOE) under the account Prizes of the Sports Development Program of the Office of the City Mayor;
