A RESOLUTION DECLARING THAT THE TWO BARANGAY ORDINANCES, ALL **ENTITLED:** "AN ORDINANCE AUTHORIZING THE CITY OF ORMOC TO BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER" UNDER REVIEW HAVE BEEN FOUND TO BE IN CONFORMITY WITH **EXISTING** LAWS AND ORDINANCES, AND INTERPOSING NO **OBJECTION** ITS IMPLEMENTATION, TO WIT:

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received copies of Ordinances from the above enumerated Barangays, all entitled: :" AN ORDINANCE AUTHORIZING THE CITY OF ORMOC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER". The copies of the Ordinances together with its attachments are hereto attached and made an integral part hereof;

WHEREAS, the ordinances were submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 and 458 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC) in order to find out whether the subject Ordinances approved by the respective Sangguniang Barangays are within the scope of its prescribed powers and also whether the same are in conformity with law and city ordinances;

WHEREAS, the enactment of the subject barangay ordinances by the concerned barangays is pursuant to EODB ACT of 2018 or Republic Act 11032, otherwise known as "An act Promoting Ease of Business and Efficient Delivery of Government Services, amending for the purpose of Republic Act No. 3485";

WHEREAS, Section 11 (f) of the above-mentioned Republic Act duly amended the Section 152 (c) of the Local Government Code and provides that "Barangay Clearances and Permits related to doing business shall be applied, issued and collected at the City/Municipality in accordance with the prescribed processing time of the said act. Provided, that the share in the collection shall be remitted to respective Barangays;

WHEREAS, this Sanggunian, in the exercise of its review powers, and after thorough examination of the aforesaid Barangay Ordinances, finds that the same were enacted for the purpose of raising revenues for the Barangay, which will in turn be utilized to deliver basic services and promote the general welfare and convenience of the Barangay constituents;

WHEREAS, this Sanggunian, finally finds that the Ordinances are valid and lawful and within the scope and authority of the Barangays, and therefore, manifests herein no objections to its implementation, and even urges that they be implemented implediately in order to speedily further the noble ends they seek for welfare of the Barangays,

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Roiland H. Villasencio, Nolito M. Quilang, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III and Joan Marbie C. Simbajon; be it



### BARANGAY ORDINANCE NO. 01 Series of 2020

AN ORDINANCE AUTHORIZING THE CITY OF ORMOC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMINTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER.

WHEREAS, under Section 152 (c) of the local Government CODE states that;

"{c} Barangay Clearance-No city or municipality may issue any license or permit for any business or activity unless a clearance is first obtained from the barangay where such business or activity is located or conducted. For such clearance, the Sangguniang Barangay may impose a reasonable fee. The application for clearance shall be acted upon within seven {7} working days from the filling thereof, in the event that the clearance is not issued within the said period the city or municipality may issue the said license permit.

WHEREAS, the EOBD ACT of 2018 or Republic Act 11032, otherwise known as "An Act Promoting ease of doing business and efficient delivery of Government Services, Amending the purpose of Republic Act No. 9485" was duly enacted.

WHEREAS, Section 11 {f} of the above-mentioned Republic act duly amended the section 152 {c} of the Local Government Code, and provides the "barangay clearance and permits related to doing business shall be applied, issued and collected at the City/Municipality accordance with the prescribed processing time of said act. Provided, that the share in the collection shall be remitted to respective barangays; and

WHEREAS, Barangay MANLILINAO, in accordance with the above provisions, and as an implementation of "one stop shop" herein authorized the City / Municipality of Ormoc. to issue barangay clearance and collect corresponding barangay clearance fee in the application for any business related transaction subject to the remittance of the aforesaid fees to the barangay and the condition hereunder,

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED by the Barangay Council of Barangay MANLILINAO in a session duly assembled the following;

SECTION 1. Coverage. This policy applies only to the issuance of Barangay Clearance for business permit and locational clearance {as a requirement for the issuance of the building permit} at the City / Municipality. Other clearances for the purposes shall be obtained at the barangay.

This Circular shall cover at City and Municipal Mayors, Punong Barangays, Concerned Local Officials, DILG Regional Director, BARMM Minister of the local government and all others concerned.

SECTION 2. Definition of Terms. The word and phrases used in this ordinance are hereby defined as follows.

Business Permits and locational/zoning clearance by the city/municipality or any other permits as may Required.

{IRR OF 11032}

City/Municipality in relation to the issuance of business permits and locational/zoning clearance by the city/municipality.

Business Permit – is a document that must be secure from the city or municipal government usually through its Business Permit and Licensing Office {BPLO}, for a business to legally operate in the locality {IRR of RA 11032}

Locational Clearance – is a clearance issued by the Zoning administrator/Zoining Office to a project that is allowed under the provisions of an ordinance of a particular City/Municipality. It is a requirements for the issuance of building permit. {House and Local use regulation Board-Comprehensive land use plan guidebook}.

SECTION 3. Authority to collect Barangay clearance fees of Business Related transaction-The City/Municipality of Ormoc is given the authority to collect Barangay Clearance fee subject to the remittance to the subject Barangay.

SECTION 4. Rate of Barangay Clearance fee to be collected-the rate of Barangay Clearance fee to be collected by the City/Municipality for the issuance clearance shall be computed in accordance with the subject Barangay revenue ordinance herein attached as "Annex A" and made as an integral part hereof.

SECTION 5. Barangay Clearance signatory-Electronics Signature of Punong Barangay concern shall in all Barangay clearance issued.

SECTION 6. Reporting and Pemittances The City/Municipality shall remit the Barangay Clearance Fee collected to the subject Barangay not later that {7} working days of the ensuring month with the list of the issued building and Business Permit.

SECTION 7. Separability Clause-if for any reason , a part of this Ordinance is declared illegal or invalid, other parts or provision hereof which are not affected thereby shall remain valid and in full force and effect.

SECTION 8. Repealing Clause-All previous Ordinance and rules/regulations with are in consist with the provisions of this ordinance are hereby deemed, modified or repealed accordingly.

SECTION 9. Effectively Clause-This ordinance shall take effect fifteen (15) days after its publication.

WHEREAS, Barangay Catmon, in accordance with the above provisions, and as an implementation of "one stop shop", hereby authorizes the City/municipality of ORMOC to issue Barangay Clearance and collect corresponding barangay clarance fee in the application for any business related transactions subject to the remittance of the aforesaid fees to the barangay and the conditions hereunder.

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED by the Barangay Council of Barangay Catmon in a session duly assembled the following:

SECTION 1. Coverage. This Policy applies only to the issuance of barangay Clearance for Business Permit and location clearance (as a requirement for the issuance of building permit) at the City/Municipality. Other Clearances for other purposes shall still be obtained at the Earangay.

This Circular shall cover all City and Municipal Mayors, Puriong Barangays, Concerned Local Officials, DILG Regional Directors and BARMM Minister of Local Government and all others concerned.

**SECTION 2.** Definition of Terms. The words and phrases used in this ordinance are hereby defined as follows:

Barangay Clearance – refers to any and all documents issued by the barangays with or without corresponding fees as defined in their relative to or in relation to the issuance of business permit and location/zoning clearance by the city/municipality or any other permit as may be required. (IRR of RA 11032)

Barangay Clearance Fees – is an amount imposed by the barangay through an ordinace and collected by the city/municipality in relation to the issuance of business permit and location/zoning clearance by the city/municipality.

Business Permit – is a document that must be secured from the city/municipal government usually through its Business Permits and Licensing Office (BPLO), for Business to legally operate in in the locality.((IRR of RA 11032)

Locational Clearance – is a clearance issued by the Zoning Administrator/ Zoning Officer to a project that is allowed under the provision of an ordinace of a particular City/Municipality. It is a requirement for the issuance of Building Permit. (House and Land Use Regulatory Board in Comprehensive Land Use Plan Guidebook)

**SECTION 3.** Authority to collect Barangay Clearance Fee of Business Related Transactions — The City/Municipality of ORMOC is given the authority to collect Barangay Clearance Fee subject to the remittance to the subject barangay.

**SECTION 4.** Rate of Barangay Clearance Fee to be Collected – The rate of Barangay Clearance Fee to be collected by the City/Municipality for the issuance clearance shall be computed in accordance with the subject Barangay Revenue Ordinace herein attached as "Annex A", and made as an integral part hereof.

**SECTION 5.** Barangay Clearance Signatory — Electronic Signature of Punong Barangay concern shall appear in all Barangay Clearance issued.

**SECTION 6.** Reporting and Remittance — The City/Municipality shall remit the Barangay Clearance Fee collected to the subject barangay not later than Seven (7) working days of the ensuing month with the list of the issued Building and Business Permit.

**SECTION 7.** Separability Clause — If for any reason, a part of this Ordiance is declared illegal or invalid, other parts or provisions hereof which are not affected thereby shall remain valid and in full force and effect.

**SECTION 8.** Repealing Clause – All provesion Ordinace and Rules/Regulation which are inconsistent with the provisions of this Ordinace are hereby deemed, modified or repealed accordingly.

SECTION 9. Effectivity Clause - This Ordiance shall take effect fifteen (15) days after its publication.
