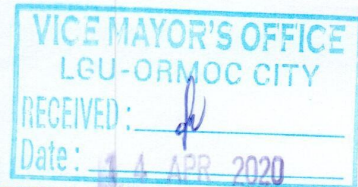

RESOLUTION NO. 2020-117

**A RESOLUTION ADOPTING A PRICE FREEZE FOR
FUNERAL SERVICES WITHIN ORMOC CITY, AS PER
RESOLUTION NO. 15 DATED MARCH 24, 2020 ISSUED
BY THE INTER-AGENCY TASK FORCE FOR THE
MANAGEMENT OF EMERGING INFECTIOUS DISEASES,
EFFECTIVE DURING THE PERIOD OF PUBLIC HEALTH
EMERGENCY, WHETHER NATIONAL OR LOCAL.**

WHEREAS, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922, declaring a State of Public Health Emergency throughout the entire Philippines, and prompting a whole-of-government approach in addressing the Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, the World Health Organization declared on March 11, 2020 that the COVID-19 outbreak can now be described as a global pandemic;

WHEREAS, on March 17, 2020, the President issued Proclamation No. 929 series of 2020 placing the entire Philippines under State of Calamity for six (6) months unless earlier lifted or extended as the circumstances may warrant;

WHEREAS, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) issued Resolution No. 15 Series of 2020 dated March 24, 2020 relative to the Management of the COVID-19 Situation;

WHEREAS, under said Resolution, the IATF recommended actions on the handling and disposal of the remains of COVID-19 confirmed cases and Persons Under Investigations (PUIs) one of which is that the local government may release issuances or ordinances to put a price cap or impose a price freeze on funeral services located within their jurisdiction;

WHEREAS, as of April 7, 2020, the Department of Health has recorded 3,764 confirmed cases and 177 deaths;

WHEREAS, in Ormoc City, although there are no confirmed cases to date, the City Health Department reported as of April 7, 2020 that there are 46 current Persons Under Investigation (PUI) and 207 Persons Under Monitoring;

WHEREAS, on a Committee Meeting conducted last April 6, 2020, funeral establishments of this City, namely; V. Rama Funeral Homes, JP Dela Cruz Memorial Chapel, Bernales Memorial Chapels, and St. Peter Life Memorial Homes submitted their list of prices for funeral services, said documents are hereto attached as Annex "A", "B", "C" and "D" respectively, and made an integral part hereof;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety;

WHEREAS, with the rising number of COVID-19 cases and deaths nationwide, the need for funeral services has increased thereby necessitating that the fees of such services be regulated, and this has been recognized with the recommendation of the IATF to put a price freeze on funeral services to protect the public from becoming victim of overpricing and to prevent funeral establishments from taking advantage of the current situation;

WHEREAS, there is a need to designate a body who will carry out the provisions herein, therefore, the City Price Coordinating Council is directed to perform such functions;

WHEREAS, upon close and thorough review, this Sanggunian finds that the aforementioned request by the City Mayor advantageous and for the best interest of the City and its inhabitants;

NOW THEREFORE, on motion of SP Member Tomas R. Serafica, Chairman of the Committee on Ways and Means, seconded by SP Members Joan Marbie C. Simbajon, Lalaine A. Marcos and Roiland H. Villasencio; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION ADOPTING A PRICE FREEZE FOR FUNERAL SERVICES WITHIN ORMOC CITY, AS PER RESOLUTION NO. 15 DATED MARCH 24, 2020 ISSUED BY THE INTER-AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES, EFFECTIVE DURING THE PERIOD OF PUBLIC HEALTH EMERGENCY, WHETHER NATIONAL OR LOCAL;


ADOPTED, April 14, 2020.
