## RESOLUTION NO. 2020-126

A RESOLUTION REQUESTING HONORABLE GOVERNOR OF CEBU PROVINCE, GWENDOLYN F. GARCIA, AND 70 ALL **MEMBERS** OF THE SANGGUNIANG PANLALAWIGAN TO **PROVIDE** ASSISTANCE TO STRANDED ORMOCANONS IN CEBU PROVINCE.

WHEREAS, Local Government Officials all over the country imposed quarantines/lockdowns in various degrees in their respective jurisdictions;

WHEREAS, as a result of these lockdowns, some Ormocanons are now stranded in Cebu Province;

WHEREAS, this group of stranded Ormocanons in Cebu may not have been listed as among those who are entitled to receive assistance in their respective areas as they are either students who have no classes or workers who have no work, and for any other reasons, all of whom have neither money, food or medications to survive these trying times;

WHEREAS, it is incumbent upon the Government to render assistance and provide aid for those in need such as medicines, food, shelter or services;

WHEREAS, in this abnormal situation, the City of Ormoc provides aid to those in need here in Ormoc in the form of food, medicines, shelter and services and stranded persons are likewise recipients of these assistance even though they are not listed as residents of any barangay in Ormoc;

WHEREAS, ex aequo et bono, the people of the City of Ormoc are appealing to the Honorable Governor Gwendolyn F. Garcia, to provide assistance in the form of food, medicines, shelter and other necessary services and when the situation so warrants, allow this group of stranded Ormocanons to travel and go home to Ormoc City after compliance with the strictest health Protocol standards and policy of Cebu Province;

WHEREFORE, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION REQUESTING THE HONORABLE GOVERNOR OF CEBU PROVINCE, GWENDOLYN F. GARCIA, AND TO ALL MEMBERS OF THE SANGGUNIANG PANLALAWIGAN TO PROVIDE ASSISTANCE IN THE FORM OF FOOD, MEDICINE, SHELTER AND OTHER NECESSARY SERVICES FOR STRANDED ORMOCANONS IN CEBU, AND WHEN THE SITUATION SO WARRANT, ALLOW THEM TO GO HOME TO THEIR HOME CITY AND JOIN THEIR FAMILIES AND LOVED ONES AFTER COMPLIANCE WITH THE STRICTEST HEALTH PROTOCOL STANDARDS AND POLICY OF CEBU PROVINCE;

ADOPTED, April 28, 2020.

RESOLVED, FURTHER, to furnish copies of this resolution one each to the City Mayor of Ormoc Richard I. Gomez; the City Administrator; the City Legal Officer; the City Health Department; the City Social Welfare & Development Office; Governor Gwendolyn F. Garcia, Province of Cebu; the Sangguniang Panlalawigan of Cebu; the City Local Government Operations Officer-DILG; and all others concerned;
