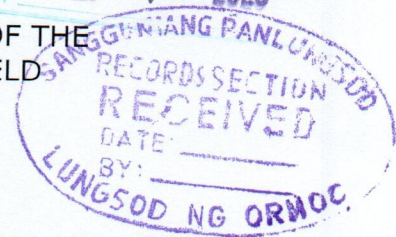
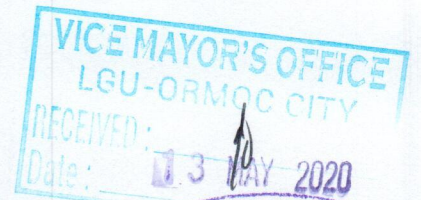

ADOPTED, May 12, 2020.


