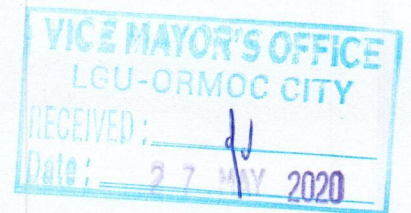

**AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO
THE CITY MAYOR RICHARD I. GOMEZ OR THE
ACTING CITY MAYOR TO ACCEPT PERISHABLE
AND/OR CONSUMABLE GOODS IN RELATION TO
CORONAVIRUS DISEASE 2019 (COVID-19) AND THE
RATIFICATION OF THE ATTACHED WITHDRAWAL
FORM (ACCEPTANCE OF DONATION) EXECUTED DUE
TO URGENCY.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated May 12, 2020 from the Office of the City Mayor, endorsing a request for the ratification of the attached Withdrawal Form (Acceptance of Donation) executed due to urgency; Further requesting for an issuance of an Omnibus Resolution granting the City Mayor or his representative to accept perishable and/or consumable goods in relation to COVID-19. Finally, requesting that this matter be treated as EXTREMELY URGENT, a copy of the Donation is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, National Grid Corporation of the Philippines (NGCP) is an electric utility company organized under the laws of the Philippines with a substation in Ormoc City is hereinafter referred to as DONOR;

WHEREAS, the DONOR is willing to donate One Thousand Eight Hundred Seventy-Five (1,875) kgs of rice, Six Hundred Twenty-Five (625) cans of corned beef, Six Hundred Twenty-Five (625) cans of canned tuna, Two Thousand Five Hundred (2,500) cans of sardines, Two Thousand Five Hundred (2,500) packs of noodles, and Six Hundred Twenty-Five (625) packs of Milk;

WHEREAS, by executing the Withdrawal Form (Acceptance of Donation), the Local Government of Ormoc hereby formally accepts the donation made by NGCP;

WHEREAS, LGU-Ormoc affirms that all donated items will be distributed to their constituents and will not be resold or distributed to other entities;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to ratify the Withdrawal Form (Acceptance of Donation), among other lawful purposes, facilitates the ongoing developmental progress of the City and henceforth, deserving of this august Body's prompt and favorable consideration;


