

WHEREAS, the Agreement is made and entered into by and among Elma Muros, Raul Abangan, Ronmols Andawa, Lauro Reyes, James Capuyan, Mikhaela Kirsten Silverio, Alvin Pangan, Nico John Susi, Clint Sayo, Reynaldo Granda, Ramon Mistica, Devy John Singson, Gonzalo Borjal, Jr., Thelma Rojas, Jose Wendell Alcos, Rigardo Canlas, Joseph Santos, Rizalie Amaro, Jasper Jimenez, John Kenneth Monterubio, Kevin Alfred Dalisay, Michael Kevin Cudiamat, Crisanta Abas, Noel Gonzalez, Clarence Lyle Caasalan, Luis Bacarisas, Sherwin Tabar, Melchor Tumas, and Ma. Cristina Vergara are hereinafter collectively referred to as CONTRACTOR;

WHEREAS, in order to contain the spread of the coronavirus disease 2019 (COVID-2019), President Duterte in a televised speech made on March 12, 2020, declared the suspension of travel to and from Metro Manila;

WHEREAS, by virtue of the Sub-level 2 declaration made by the National Government last March 12, 2020 relative to COVID-19, which has already harmed the many and may spread during mass gatherings/interactions, EVRAA 2020 was then ordered cancelled;

WHEREAS, the CONTRACTOR has agreed to perform services for LGU-Ormoc in connection with its Sports Programs, relative to the 2020 EVRAA preparation;

WHEREAS, the CONTRACTOR agreed to provide services for a period of Fifteen (15) days for a consideration of Four Thousand Philippine Pesos (Php4,000.00) per day;

WHEREAS, the CONTRACTOR and the City have agreed that the latter shall only pay for the days where services are actually rendered on account of the said contract;

WHEREAS, the CONTRACTOR hereby agrees to waive, quit claim, and relinquish all our rights and interests for all the remaining days not yet rendered;

WHEREAS, the subject agreement clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same is entered into for the best interests of the City and its constituents and therefore, is most deserving of this august Body's prompt and favorable consideration;
