A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION, TO BE MADE AND EXECUTED BY AND BETWEEN PHILIPPINE ASSOCIATED SMELTING AND REFINING CORPORATION (PASAR) FOUNDATION INC. AND CITY GOVERNMENT OF ORMOC FOR THE DONATION OF TWO HUNDRED FORTY-EIGHT (248) PIECES OF MIXED LUMBERS AND SLABS WITH A VOLUME OF THREE THOUSAND THIRTEEN AND THIRTY-FOUR (3,013.34) BOARD FEET AND SEVENTY-FOUR (74) PIECES OF PLASTIC DRUMS.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated May 21, 2020 from the Office of the City Mayor, requesting for an issuance of Resolution granting the City Mayor or Acting City Mayor the authority to accept and sign the attached Deed of Donation, to be made and executed by and between PASAR FOUNDATION INC. and City Government of Ormoc, for the donated Two Hundred Forty-Eight (248) pieces mixed lumbers and slabs with volume 3,013.34 bd. ft. and Seventy-Four (74) pieces plastic drums. Further requesting that this matter be treated as EXTREMELY URGENT, a copy of the Deed of Donation is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, PASAR FOUNDATION INC. is a non-stock, non-profit and non-government organization duly organized and existing under the laws of the Philippines, with principal office address at Brgy. Libertad, Isabel, Leyte hereinafter referred to as DONOR;

WHEREAS, the City of Ormoc is a Local Government Unit, duly established under the laws of the Republic of the Philippines hereinafter referred to as DONEE;

WHEREAS, in a Letter received on May 21, 2020, the Environment and Natural Resources Office (ENRO) forwarded the Deed of Donation to the Office of the City Mayor with the following donated items: 1.) mixed lumbers and slabs to be used in the making of One Hundred Fifty (150) beds and 2.) plastic drums to be used as storage drums for rain water catching and as trash receptacles for the Ormoc COVID Quarantine/Isolation Facility in NHA Housing at Dolores, Ormoc City;

WHEREAS, the Constitution states that "The State shall protect and promote the right of the people and instill health consciousness among them";

WHEREAS, the Constitution further declares that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, on January 30, 2020 the World Health Organization (WHO) declared the Coronavirus Disease (COVID-19) outbreak a Public Health Emergency of International Concern (PHEIC), following which and on March 11, 2020, the spread of the same virus was characterized COVID-19 as a pandemic;

WHEREAS, to prevent, if not mitigate, the spread of the infectious disease, the City has identified and established a quarantine and isolation facility, hereinafter referred to as "Facility" wherein persons suspected and/or exposed to the disease may be quarantined or isolated, at the NHA Housing located at Brgy. Dolores, Ormoc City;

WHEREAS, the facility has bare units and requires, among others, bed frames, water tanks, and trash receptacles;

WHEREAS, the formulation implementation of policies and measures on local autonomy shall be guided by the principle that the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, DONOR is a non-stock, non-profit and non-government organization desirous of extending assistance to the DONEE in furnishing subject facility and has the resources and capacity to extend such assistance;

WHEREAS, the DONOR, is a holder of Certificate of Private Tree Plantation Ownership (CTPO) No. ORM 2-5-20-012 for their managed and developed tree plantation located at Brgy. Libertad, Isabel, Leyte; and has accumulated empty plastic drums;

WHEREAS, for and in consideration of the foregoing premises, and the DONOR's pure generosity and liberality, the DONOR hereby TRANSFERS and CONVEYS, unto the DONEE, by way of DONATION, the following:

- a. Two Hundred Forty-Eight (248) pieces of lumber with total volume of 3,013.34 bd. ft., amounting to Forty-Five Thousand Two Hundred Twenty-Five Philippine Pesos (Php45,225.00), for its use as raw wood materials for the construction of One Hundred Fifty (150) standard sized single beds; AND
- b. Seventy-Four (74) pieces of used empty plastic drums, with a value of Five Hundred Philippine Pesos (Php500.00) per drum, amounting to Thirty-Seven Thousand Philippine Pesos (Php37,000.00), for rainwater catchment and trash drums/receptacles.

WHEREAS, this Sanggunian, after thorough examination aforementioned request by the City Mayor, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to accept and sign the Deed of Donation, among other lawful purposes, facilitates the ongoing developmental progress of the City and henceforth, deserving of this august Body's prompt and favorable consideration;

AND CITY GOVERNMENT OF ORMOC FOR THE DONATION OF TWO HUNDRED FORTY-EIGHT (248) PIECES OF MIXED LUMBERS AND SLABS WITH A VOLUME OF THREE THOUSAND THIRTEEN AND THIRTY-FOUR (3,013.34) BOARD FEET AND SEVENTY-FOUR (74) PIECES OF PLASTIC DRUMS;

b. Seventy-four (74) pieces used empty Plastic Drums, with a value of two handred pesos (P500.00) per drum, amounting to Thirty-seven Thousand Pesos (P37, 000.00), for rain water catchment and trash drums/receptacles.

The donated lumber shall be used by the DONEE for construction of one hundred lifty (150) pcs of standard sized single beds frames intended for the Facility;

DONOR shall secure the permits necessary for the cutting, processing, transporting, and all acts relative thereto, requisite to effect the use of the lumber donated;

DONEE shall arrange and undertake the pick-up of above-described properties, from the custody/premises of DONOR, and transport the same to DONEE's premises/facility;

DONEE shall undertake the construction of all wooden bed frames and deliver the same to the Facility;

DONEE shall use and/or convert the donated plastic drums into rain water catchment and trash receptacles for the Facility, the respective number of which shall be determined by DONEE;

DONEE shall maintain above-described property in the Facility for the duration of the purpose for which the Facility was established, and shall determine the disposition of above-described property after the Facility's purpose is abandoned;

DONEE shall hold the DONOR free and harmless from and against, all demands, claims, liabilities, losses, damages, costs, expenses, charges, and/or fees which the DONOR may incur or sustain by reason of any and all claims which may arise from this Deed.

The Parties warrant, represent and undertake: (i) that neither it nor any of its representatives has exerted or utilized any corrupt or unlawful practice to secure or solicit this agreement; and (ii) that it will comply with all applicable laws, rules and regulations including without limitation, anti-corruption and anti-money laundering laws in performing this agreement.

DONEE hereby ACCEPTS AND RECEIVES the donation of above-described property, and expresses its gratitude and appreciation for the support, kindness and liberality of the DONOR.
