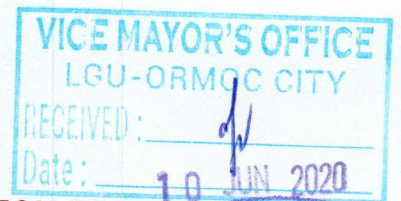

**A RESOLUTION INTERPOSING NO OBJECTION FOR THE
SOLAR INSTALLATION OF 1,112.65 KW ON THE
ROOFTOP OF ROBINSONS PLACE ORMOC LOCATED IN
BARANGAY COGON, ORMOC CITY FOR THE SAID
MALL'S OWN USE.**

WHEREAS, the Local Government Code (RA 7160) mandates for every Local Government Unit to exercise its inherent powers, as well as share with the national government the responsibility in the management and maintenance of ecological balance in its respective territorial jurisdiction;

WHEREAS, a letter dated May 5, 2020 from Upgrade Energy Philippines (UGEP) addressed to the Sangguniang Panlungsod (SP) of Ormoc City requesting for the SP to create a Resolution approving the Solar Installation Project located in Robinsons Place Ormoc; and which the Office of the Vice Mayor of Ormoc City respectfully endorsed to SP Member Lalaine Marcos, as the Chairman of the Committee on Environment, Natural Resources, and Energy Conservation in an Endorsement Letter dated May 26, 2020;

WHEREAS, the said Resolution is an important Requirement for UGEP's application for a Certificate of Registration with the Department of Energy (DoE), specifically UGEP's Renewable Energy (RE) Contract Application with the said Department;

WHEREAS, UGEP has successfully secured already from Ormoc City's Office of the Building Official (OBO) a Certificate of Occupancy and a Certificate of Use in compliance with Ormoc City's regulations;

WHEREAS, the Office of the City Legal Officer and the City's Environment and Natural Resources Office (ENRO) found nothing legally objectionable, adding it is not contrary to law, morals, public order or public policy, much less detrimental to the best interest of LGU-Ormoc City;

WHEREFORE, on motion of SP Member Lalaine Marcos, Chairman, Committee on Environment, Natural Resources, and Energy Conservation, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Esteban V. Laurente and Joan Marbie C. Simbajon; be it


