A RESOLUTION GRANTING AUTHORITY TO THE CITY TREASURER, MS. DELIA C. VILBAR, TO OPEN SPECIAL BANK ACCOUNTS WITH LANDBANK CRMOC BRANCH TO FACILITATE FUND TRANSFERS FROM THE DEPARTMENT OF ENERGY (DOE) IN ACCORDANCE WITH DOE DEPARTMENT CIRCULAR NO. 2020-04-00080 ENTITLED RATIONALIZING THE UTTLIZATION OF ENERGY REGULATION 1-94 (ER 1-94) FUNDS TO HOST LOCAL GOVERNMENT UNITS IN RESPONSE TO CORONAVIRUS DISEASE 2019 (COVID-19) UNDER THE ACCOUNT NAMES, TO WIT:

WHEREAS, the Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement Letter from the City Mayor's Office (CMO) dated May 26, 2020, relative to the request of Ms. Delia C. Vilbar, City Treasurer, requesting for an issuance of a resolution granting authority to open two (2) new Interest Bearing Current Accounts (IBCA) in relation to DOE Department Circular No. 2020-04-00080, instructing all Gencos to remit the unremitted funds of Energy Regulations 1-94 (ER 1-94) Fund to the Local Government Unit for utilization to the Coronavirus Diseases 2019 (COVID -19) public emergency response;

WHEREAS, Section 5 of Republic Act No. 7638, otherwise known as the "Department of Energy Act of 1992" mandates the Department of Energy (DOE) to devise ways and means of giving direct benefits to the province, city, or municipality, especially the community and people affected, and equitable preferential benefit to the region that hosts the energy resource and/or the energy-generating-facility;

WHEREAS, the DOE promulgated Energy Regulations No. 1-94 (ER 1-94) on August 1, 1994 to operationalize the implementation of Section 5 of Republic Act No. 7638, which regulation provides for the nature of benefits and scope of benefits the community and people affected, the pertinent host local government unit (LGU) shall be entitled to from the energy resource developer or power producer;

WHEREAS, pursuant to Section 12 of DOE Circular No. 2018-08-0021, the DOE issued Department Order (DO) No. 2019-01-0001 entitled "Providing the Internal Guidelines and Procedures for the Transfer of Existing Funds in Relation to the Financial Benefits Under ER 1-94" to facilitate the transfer of existing ER 1-94 funds to qualified distribution utilities and host communities;

WHEREAS, as home to the solar power plant First Solar Energy Corporation, Ormoc City is considered as a Host LGU as defined by DC2018-08-0021;

WHEREAS, on March 16, 2020, the President issued Proclamation No. 929, Declaring a State of Calamity throughout the Philippines due to the COVID-19;

WHEREAS, the DOE issued Department Order (DO) Circular No. 2020-04-00080 entitled "Rationalizing the Utilization of ER 1-94 Funds by Host Local Government Units in Response to COVID-19 Public Health Emergency" which took effect last April 6, 2020 stating that Host LGUs can now use these funds to undertake their duty to mitigate, if not, contain the COVID-19 and issuing the corresponding framework to utilize ER 1-94 Funds to bolster their efforts to the COVID-19 crisis in their respective areas;

WHEREAS, Section 4 of the aforesaid circular requires that the ER 1-94 Fund upon allocation and compliance of requirement shall be remitted to the DLF and RWMHEEF Trust Account of the respective Host LGUs;

WHEREAS, for this reason, in an email from the First Solar Energy Corporation dated April 17, 2020 to the City Planning and Development Office (CPDO) making a follow up on the LGU application of Trust Accounts for the ER 1-94 Funds in connection with the DOE Department Circular instructing all GenCos to remit the unremitted funds of EF to Host LGU's for utilization to the COVID-19 public emergency response; a copy of said letter shall be attached hereto as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds the request of the City Mayor's Office to authorize the City Treasurer, Ms. Delia C. Vilbar, to open herein subject bank account as truly beneficial and will immensely be favorable to City of Ormoc and its constituents, and therefore, most deserving of this august Body's utmost and favorable consideration


