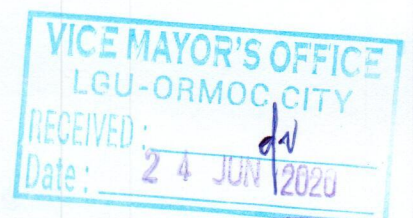

**AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO
THE CITY MAYOR RICHARD I. GOMEZ OR THE
ACTING CITY MAYOR TO ENTER INTO AND SIGN THE
MEMORANDUM OF AGREEMENTS (MOAs) WITH
CRISTINA BUSINESS SUITE, ORMOC VILLA HOTEL
AND DON FELIPE HOTEL SUBJECT TO RATIFICATION
BY THIS SANGGUNIAN RELATIVE TO THE
IMPLEMENTATION OF THE RESIDENT RECOVERY
PROGRAM AND OTHER COVID-19 QUARANTINE
PROTOCOL.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 19, 2020 from the Office of the City Mayor, endorsing a request for the issuance of an Omnibus Resolution granting the City Mayor or the Acting City Mayor the authority to enter into and sign the Memorandum of Agreements (MOAs) with Cristina Business Suite, Ormoc Villa Hotel and Don Felipe Hotel subject to ratification by this Sanggunian relative to the implementation of the Resident Recovery Program and other covid-19 quarantine protocol;

WHEREAS, Cristina Business Suite, Ormoc Villa Hotel and Don Felipe Hotel are corporations duly organized and existing under the laws of the Philippines, with principal addresses at Osmeña St., Brgy. District 11, Obrero St., Brgy. District 12 and Iñaki Larrazabal Boulevard, Brgy. District 2, Ormoc City, respectively are hereinafter collectively referred to as the COMPANY;

WHEREAS, it is mandated in the guidelines that all stranded Ormocanons coming from areas outside Ormoc that have local or community transmission of COVID-19 upon entry to the port of Ormoc and those required to be quarantined pursuant to national and local health protocols must be brought to a quarantine facility;

WHEREAS, the said EO provides that returning residents may have the option to be quarantined at a hotel supervised by the LGU-ORMOC, for which all expenses of said quarantine (accommodations, food and all costs incurred during and by reason of his/her stay) shall be for the account of the resident or his parent/guardian;

WHEREAS, the COMPANY is amenable to accept these residents and establish the Cristina Business Suite, Ormoc Villa Hotel and Don Felipe Hotel as quarantine facilities of the LGU ORMOC;

WHEREAS, LGU-ORMOC and the COMPANY hereby agreed that the latter's hotels shall be used as quarantine facilities for stranded residents who wish to be quarantined in a hotel at their own expense, under the supervision and control of the former;

WHEREAS, the subject agreements that shall be ratified by this Sanggunian shall clearly and plainly encapsulate the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same are to be entered into for the best interests of the City and its constituents thereby maintaining a COVID free environment, and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairperson, Committee on Good Government and Oversight, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Vincent L. Rama, Gregorio G. Yrastorza III, Lalaine E. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENTS (MOAs) WITH CRISTINA BUSINESS SUITE, ORMOC VILLA HOTEL AND DON FELIPE HOTEL SUBJECT TO RATIFICATION BY THIS SANGGUNIAN RELATIVE TO THE IMPLEMENTATION OF THE RESIDENT RECOVERY PROGRAM AND OTHER COVID-19 QUARANTINE PROTOCOL;


RESOLVED, FURTHER, that a copy of the final notarized Memorandum of Agreements (MOAs) be submitted to this Sanggunian for its information and files;
