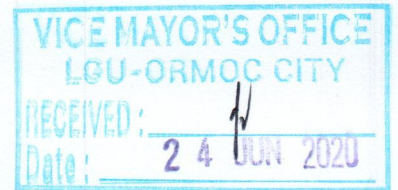
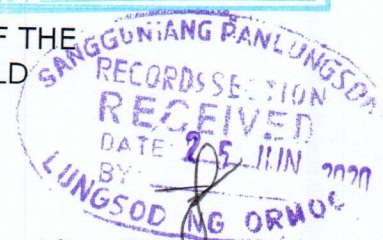

**RESOLUTION NO. 2020-185**

**A RESOLUTION ADOPTING THE PEACE AND ORDER AND  
PUBLIC SAFETY (POPS) PLAN FOR CALENDAR YEAR  
(CY) 2020-2022**

WHEREAS, DILG Memorandum Circular No. 2015-128, dated November 2, 2015, provides the guidelines on the formulation of the Peace and Order and Public Safety Plan (POPS Plan), calling for the formulation of a three-year term based POPS Plan by every Provincial, City and Municipality Peace and Order Council and Barangay Peace and Order Committee;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2015-130, dated November 03, 2015, provides the guidelines on the functions of the Peace and Order Councils, wherein it is stated that one of the functions of the City Peace and Order Council is to formulate a three-year Local Peace and Order Council (LPOC) Peace and Order and Public Safety (POPS) Plan;

WHEREAS, on February of 2020, Ormoc City has formulated, through a workshop, a Peace and Order and Public Safety (POPS) Plan for Calendar Year 2020-2022 indicating the Program, Plans, Services and Activities (PPSAs) of the City to address issues and needs related to Peace and Order and Public Safety;

WHEREAS, the Peace and Order and Public Safety (POPS) Plan for Calendar Year 2020-2022 was approved by the City Peace and Order Council on February 27, 2020;

WHEREAS, there is a need to pass a Resolution adopting the Peace and Order and Public Safety (POPS) Plan for Calendar Year 2020-2022 by the 15<sup>th</sup> Sangguniang Panlungsod ng Ormoc;


