A RESOLUTION EXPRESSING THE SUPPORT OF THE CITY GOVERNMENT OF ORMOO ON THE ESTABLISHMENT OF SALVACION NATIONAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY AND THE COMMITMENT TO SUPPORT THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS NEEDED ARE INCORPORATED IN THE NATIONAL BUDGET.

WHICREAS, this august Body was in receipt of two (2) Local School Board (LSB) resolutions, dated 26 May 2020, requesting for appropriate action, to wit:

- 1. Resolution No. 2020-06: "A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLUNGSOD NG ORMOC THE ESTABLISHMENT OF SALVACION NATIONAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY";
- 2. Resolution No. 2020-08: "A RESOLUTION ENDORSING TO THE 15TH SANGGUNIANG PANLUNGSOD THE REQUEST FOR CONTINUED COMMITMENT AND SUPPORT OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY TO SALVACION NATIONAL HIGH SCHOOL IN THE NEXT FIVE (5) YEARS AND TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN DEPED AND THE LOCAL GOVERNMENT UNIT OF ORMOC".

WHEREAS, to recall, the 14th Sangguniang Panlungsod ng Ormoc passed Resolution No. 086 series of 2019 supporting the endorsement of the LSB for the establishment of Salvacion Agro-Industrial High School in Barangay Salvacion. However, it does not qualify to provide specialized training and skills development in agriculture and industry considering the area requirement of the said agroindustrial school, hence the proposal to establish a national high school in its stead;

WHEREAS, the need to establish a high school in Barangay Salvacion is justified by the distance of the said barangay from existing high schools in Barangay Liloan and Barangay Valencia, Ormoc City and from the New Ormoc City National High School (NOCNHS). The said barangay is also strategically located and accessible to neighboring barangays such as Barangays Airport, Dayhagan, Juaton, Sto. Niño, San Pablo and Nasunogan. These barangays produce a good number of elementary graduates sufficient enough to open a new National High School.

WHEREAS, the proposed opening of a new National High School in Barangay Salvacion would bring the educational system close to the communities and ensure easier access to high school especially among the poor families where drop outs are observed and somehow encourage students to continue their education eventually decreasing the number of out-of-school youth;

WHEREAS, there is a need for additional schools to accommodate the increasing number of incoming high school students coming from neighboring communities of Barangay Salvacion which is also consonant to the thrust of DEPED Ormoc Division Office to decongest New Ormoc City National High School (NOCNHS) that is currently suffering from heavy congestion and overcrowding of students;

WHEREAS, pursuant to Section VI (B.1) of DepEd Order No. 40, s. 2014, the proposed establishment of school must be supported by the local government unit through Sangguniang Panlungsod Resolution supporting the establishment of school, duly approved by the City Mayor, indicating therein the proposed name of the school;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it promotes better access to education among the youth especially among poor families who would likely have difficulties sending their children to school due to distance so therefore, most deserving of this august Body's full support and affirmative action;

WHEREFORE, on MASS MOTION of the Body; be it

RESOLVED AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EXPRESSING THE SUPPORT OF THE CITY GOVERNMENT OF ORMOC ON THE ESTABLISHMENT OF SALVACION NATIONAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY AND THE COMMITMENT TO SUPPORT THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS NEEDED ARE INCORPORATED IN THE NATIONAL BUDGET;

A RESOLUTION ENDORSING TO THE 15TH SANGUNIANG PANLUNGSOD NG ORMOC THE ESTABLISHMENT OF SALVACION NATIONAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY;

WHEREAS, the Local School Board received the letter from SDS Lani Cervantes requesting for an immediate consideration of the Barangay Resolution No. 21-2018 of Barangay Salvacion Council to establish a secondary school namely Salvacion National High School;

WHEREAS, the said high school previously known as Salvacion Agro-Industrial School as per Resolution No. 086 series of 2019 of the 14th Sangguniang Panglungsod however it does not qualify to provide specialized training and skills development in agriculture and industry considering the area requirement of the said agro-industrial school, hence the proposal to establish it as a national high school,

WHEREAS, Assistant School Principal Dr. Abel Dayandayan who was also present in the Local School Board meeting dated February 17, 2020 explained that the required Sanguniang Panglungsod Resolution is not to rename Salvacion Agro-Industrial School but to establish it as a national High School and be named Salvacion National High School as one of the needed requirements in establishing a new public school as stipulated in the guidelines of DepEd Order No. 40 series 2014

WHEREAS, the request for the establishment of the said high school is also in line with the application for government permit to operate a secondary school in Brgy. Salvacion, Ormoc City, Leyte;

WHEREAS, the need to establish high school in Brgy. Salvacion is justified by the distance of the said barangay from existing high schools in Liloan, Ormoc City and from New Ormoc City National High School and the said school in Brgy. Salvacion is also accessible to neighboring barangays including Nasunugan, Airport, Dayhagan and Juaton, Sto. Niño and San Pablo;

WHEREAS, upon review and deliberation, the Local School Board finds the proposal meritorious and such is right and just, and therefore is deserving of prompt and favorable action;
