A RESOLUTION EXPRESSING THE SUPPORT OF THE CITY GOVERNMENT OF ORMOC ON THE CONVERSION OF ORMOC CITY SPED CENTER INTO ORMOC CITY SPED INTEGRATED SCHOOL AND COMMITMENT TO SUPPORT THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS NEEDED ARE INCORPORATED IN THE NATIONAL BUDGET.

WHEREAS, this august Body was in receipt of Local School Board (LSB) Resolution No. 2020-07 recommending for the conversion of Ormoc City SPED Center into Ormoc City SPED Integrated School and requesting for the support of the Local Government Unit of Ormoc (LGU-Ormoc) in the operation of the school in the next five (5) years. A copy of the said resolution is hereto attached and made an integral part hereof;

WHEREAS, pursuant to Section VI (B.4) of Deped Order No. 40, s. 2014, the proposed conversion of school(s) into and Integrated School (IS) must be supported by the local government unit through a Sangguniang Panlungsod Resolution supporting the conversion of the school into an IS, duly approved by the City Mayor, indicating therein the proposed name of the school; and certification from the LGU signed by the City Mayor, as the case may be, where the LGU shall continue to provide funds for the operation and maintenance for at least 5 years or until such time that such funds are incorporated in the national budget;

WHEREAS, Ormoc City SPED Center only offers special education to elementary graded and non-graded students and therefore graded physically challenged children who wish to continue their high school education will have to enroll in Maasin City which was a difficult option for families of the graduates of the SPED Center and this resulted to drop outs among many of the special children;

A STATE OF THE PROPERTY OF THE

WHEREAS, some special children like the hearing impaired opted to try their high school education at the New Ormoc City National High School (NOCHS) but because they are mix with regular students, the mainstreaming was very challenging not only to the student but also for the teacher since she/he has to learn sign language in order to provide instructions and teach at the same time;

WHEREAS, the special education curriculum available in Ormoc City also catered to special children in nearby municipalities of the fourth district of Leyte;

WHEREAS, considering all the foregoing premises and upon close and thorough review, this Sanggunian finds that the request for a resolution expressing support to the conversion of Ormoc City SPED Center into Ormoc City SPED Integrated School is not contrary to law, public policy, and public morals and that said conversion is beneficial to the City of Ormoc in providing inclusive learning practices for the physically impaired children which will eventually contribute to reduce number of drop-outs and out-of-school youth and therefore most deserving of this august Body's full support and affirmative action;

WHEREFORE, on motion of SP Member Nolito M. Quilang, Chairman, Committee, on Education, severally seconded by SP Members Roiland H. Villasencio, Gregorio G. Yrastorza III, Vincent L. Rama, Lalaine A. Marcos, Esteban V. Laurente and Joan Marbie C. Simbajon; be it

RESOLVED AS IT IS HEREBY RESOLVED, to pass A RESOLUTION EXPRESSING THE SUPPORT OF THE CITY GOVERNMENT OF ORMOC ON THE CONVERSION OF ORMOC CITY SPED CENTER INTO ORMOC CITY SPED INTEGRATED SCHOOL AND COMMITMENT TO SUPPORT THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS NEEDED ARE INCORPORATED IN THE NATIONAL BUDGET;

A RESOLUTION RECOMMENDING TO THE 15th SANGUNIANG PANGLUNGSOD THE CONVERSION OF ORMOC CITY SPED CENTER TO ORMOC CITY SPED INTEGRATED SCHOOL AND SECURING THE SUPPORT OF THE LOCAL GOVERNMENT UNIT OF ORMOC IN THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS;

WHEREAS, during the Local School Board meeting on February 17, 2020, Assistant Principal Melissa Bughao presented the proposal for the conversion of Ormoc City SPED Center to Ormoc City SPED Integrated School;

WHEREAS, Ormoc City SPED Center currently offers elementary level only since the secondary level which was previously inside the New Ormoc City National High School premises was transferred to Maasin City;

WHEREAS, not all Ormoc City SPED Center elementary graduates can afford to go to Maasin City to continue their secondary education, hence the need to offer secondary education in the said school;

WHEREAS, the need to convert Ormoc City SPED Center to Ormoc City SPED Integrated School is consonant with the City's thrust to reduce the drop-out rate of students since Ormoc City SPED Center elementary graduates will no longer need to go to Maasin City;

WHEREAS, the proposed conversion of Ormoc City SPED Center to Ormoc City SPED Integrated School needs support from the Local Government Unit through a Sangguniang Panglungsod Resolution and certification where the Local Government Unit of Ormoc shall continue to provide funds for operation and maintenance of the school in the next five (5) years or until such time that the needed funds for the foregoing are already provided in the national budget;

NOW, THEREFORE, upon the motion of SDS Lani Cervantes duly seconded by Mr. Reynaldo Codog, with no objection from the members, and approved by the presiding officer, be it:
