A RESOLUTION APPROVING AND GRANTING AUTHORITY TO THE PUBLIC MARKET OFFICE TO PURCHASE ONE (1) UNIT MULTI-PURPOSE SERVICE VEHICLE IN THE AMOUNT OF ONE MILLION NINE HUNDRED FORTY THOUSAND PHILIPPINE RESOS (PHP1,940,000.00).

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated March 9, 2020 respectfully endorsing the request of Mr. Ruel G. Cañete, Market Administrator, for the passage of a Resolution granting authority to purchase One (1) unit, Twenty-one (21) seater, Multi-Purpose, Diesel-fed Vehicle, for the amount of ONE MILLION NINE HUNDRED FORTY THOUSAND PHILIPPINE PESOS (PHP1,940,000.00);

WHEREAS, the requested vehicle shall be used by the Office of the Public Market Administrator, the primary arm of the Local Government Unit of Ormoc City in the maintenance, administration, and operation of the Ormoc City Public Market and other adjacent properties under their administration for replacement of their old and dilapidated vehicles and for the ease of transport of the Public Market Office personnel and equipment to and from the Ormoc City Hall or other destination for official transaction;

WHEREAS, the City Accountant, City Budget Officer, and the City Treasurer issued a Certificate of Availability of Funds dated March 5, 2020 stating therein that the Public Market Office has available funds for the purchase of the aforementioned vehicle in the amount of ONE MILLION NINE HUNDRED FORTY THOUSAND PHILIPPINE PESOS (PHP1,940,000.00) to be sourced from the General Fund-Capital Outlay for Motor Vehicles particularly from CY 2016 for the amount of ONE MILLION SEVEN HUNDRED THIRTY-SIX THOUSAND SEVEN HUNDRED FORTY-EIGHT PHILIPPINE (PHP1,736,748,000.00) and CY 2017 Unexpended Continuing Appropriation for the remaining amount of TWO HUNDRED THREE THOUSAND TWO HUNDRED FIFTY-TWO PHILIPPINE PESOS (PHP203,252.00), a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;
