AN OMNIBUS RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENTS (MOAS) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE NATIONAL IRRIGATION ADMINISTRATION (NIA) AND THE ENERGY DEVELOPMENT CORPORATION (EDC) FOR THE COMPLETION OF THE INSTALLATION AND COMMISSIONING OF THE EARLY WARNING SYSTEMLOCAL FLOOD WARNING SENSOR.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 3, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreements (MOAs) with the National Irrigation Authority (NIA) and the Energy Development Corporation (EDC). This is a requirement for the completion of the installation and commissioning of the Early Warning System-Local Flood Warning Sensor, a copy of the MOAs is hereto attached as ANNEX "A" and ANNEX "B" respectively and made an integral parts hereof;

WHEREAS, in a Letter dated May 22, 2020, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City. Further recommending that the said MOA be endorsed to the Sangguniang Panlungsod for the issuance of a Resolution granting the City Mayor the authority to enter into and sign the said agreement in behalf of the LGU, a copy of the Opinion is hereto attached as "ANNEX C" and made an integral part hereof;

WHEREAS, in a letter received on May 14, 2020, the Ormoc City Disaster and Risk Reduction Management Office (CDRRMO) informed the Office of the City Mayor that it has finished installation and commissioning of Early Warning System-Local Flood Warning Sensor amounting to Two Million Five Hundred Thirty-Eight Thousand Seven Hundred Ninety-Seven Philippine Pesos and Sixty-Three Centavos (Php2,538,797.63) in four different locations, namely:

a. SITE 1 : Purok 3, Brgy. R.M. Tan, Ormoc City

b. SITE 2 : Brgy. Cacao, Kananga, Leyte

c. SITE 3 : NIA RIS Dam, Brgy. Montebello, Kananga, Leyte

d. SITE 4 : PAD 4RD, EDC Compound, Brgy. Rizal, Kananga, Leyte

WHEREAS, National Irrigation Administration, a government entity primarily responsible for irrigation development and management;

WHEREAS, Energy Development Corporation Tongonan Geothermal Project, a private entity involved in geothermal energy:

WHEREAS, Local Government Units are encouraged to develop programs that will provide knowledge and capacities that will effectively anticipate, respond, and recover from the impacts of likely, imminent, or current hazard events or conditions;

WHEREAS, Section 3 (J) and (Q) of RA 10121 provides for disaster preparedness and early warning systems as a step to prevent or if not alleviate the effects of hazard events or conditions:

WITNESSETH:

WHEREAS, Local Government Units are encouraged to develop programs that will provide knowledge and capacities that will effectively anticipate, respond and recover from the impacts of likely, imminent or current hazard events or conditions.

WHEREAS, Section 3 (J) and (Q) of RA 10121 provides for disaster preparedness and early warning systems as a step to prevent or if not alleviate the effects of hazard events or conditions.

- a. The FIRST PARTY shall install ONE UNIT of AUTOMATED WATER LEVEL SENSOR on NIA BAO RIS DAM at BRGY. MONTEBELLO, MUNICIPALITY OF KANANGA with coordinates N 11.12396° E 124.58667° ±3M.
- The FIRST PARTY shall cover all the expenses for the procurement, installation, commissioning and maintenance of the WATER LEVEL SENSOR.
- c. The ownership of the instrument and all other improvements or structures introduced therein shall remain with the FIRST PARTY.
- d. The FIRST PARTY will share to the SECOND PARTY obtain current and/or historical data of the said instrument upon request.
- e. The SECOND PARTY will notify the FIRST PARTY 30 days prior any civil works to be done on the sensors location that requires the instrument to be properly removed or relocated.
- f. That the SECOND PARTY shall assist the FIRST PARTY in informing the in charge NIA in charged personnel of the said facility regarding the existence of the said device.
- g. That the FIRST AND SECOND PARTY shall work hand in hand to protect and preserve the said instrument by stressing its importance on their employee.
- h. In case of any dispute and in order to forestall lengthy and tedious court proceedings, the same shall be resolved first through a committee or arbitration panel to be composed in accordance with the supplemental agreement of the parties which shall be a composite part of this agreement.
- i. This Memorandum of Agreement shall take effect upon signing by the two Parties and shall remain in force until revoked by the concerned PARTY and/or higher authorities, subject to a written notice given thirty (30) days in advance.

- b. The FIRST PARTY shall cover all the expenses for the procurement, installation, commissioning and maintenance of the AUTOMATED RAIN GUAGE SENSOR.
- c. The ownership of the instrument and all other improvements or structures introduced therein shall remain with the FIRST PARTY.
- d. The Second party agree to let the First Party enter in PAD 4RD for the purpose of maintenance and repair of the Automated Rain Gauge Sensor with notice and approval of the Second Party.
- e. The FIRST PARTY will share to the SECOND PARTY obtain current and/or historical data of the said instrument upon request.
- f. The SECOND PARTY will notify the FIRST PARTY 30 days prior any civil works to be done on the sensors location that requires the instrument to be properly removed or relocated.
- g. That the FIRST AND SECOND PARTY shall work hand in hand to protect and preserve the said instrument by stressing its importance on their locality community work place.
- h. In case of any dispute and in order to forestall lengthy and tedious court proceedings, the same shall be resolved first through a committee or arbitration panel to be composed in accordance with the supplemental agreement of the parties which shall be a composite part of this agreement.
