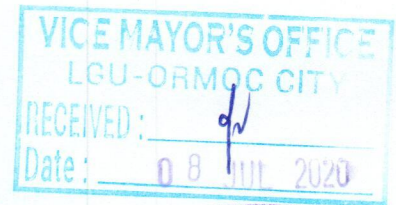
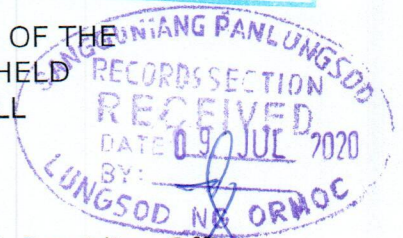

**A RESOLUTION GRANTING AUTHORITY TO THE CITY
MAYOR RICHARD I. GOMEZ OR THE ACTING CITY
MAYOR TO ACCEPT AND SIGN THE DEED OF
DONATION, TO BE MADE AND EXECUTED BY AND
BETWEEN THE DEPARTMENT OF ENVIRONMENT AND
NATURAL RESOURCES (DENR) AS DONOR AND CITY
GOVERNMENT OF ORMOC AS DONEE, FOR FOUR
THOUSAND TWO HUNDRED FIFTY (4,250) BD. FT.
LUMBER/FLITCHES IN VARIOUS SIZES AND
DIMENSION DEPOSITED AT EDC ORMOC COMPOUND
TO BE USED IN THE MAKING OF ONE HUNDRED FIFTY
(150) BEDS FOR THE ORMOC COVID
QUARANTINE/ISOLATION FACILITY/NHA HOUSING,
AT DOLORES, ORMOC CITY.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 24, 2020 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor to accept and sign the Deed of Donation, to be made and executed by and between the DENR as Donor and City Government of Ormoc as Donee for Four Thousand Two Hundred Fifty (4,250) bd. ft. lumber/flitches in various sizes and dimension deposited at EDC Ormoc Compound to be used in the making of One Hundred Fifty (150) beds for the Ormoc Covid Quarantine/Isolation Facility/NHA Housing, at Dolores, Ormoc City, a copy of the Deed of Donation is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, in a Letter dated June 18, 2020, the Environment and Natural Resources Office forwarded to the Office of the City Mayor the draft Deed of Donation containing 4,250 bd. ft. of lumber/flitches in various sizes and dimension to be used in the making of 150 beds for Ormoc COVID Quarantine/Isolation Facility/NHA Housing at Dolores, a copy of the Letter is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, in support of Bayanihan Heal as One Act and Executive Order No. 114 – Balik Probinsya, Bagong Pag-asa Program, the Donor wishes to convey, by way of donation, unto said Donee, thru its representative, 4,250 bd. ft. lumber/flitches in various size and dimensions;

WHEREAS, the subject logs earmarked for donation were the timber cut during EDC operation under STCP Nos. R8-01-140415 issued sometime in CY 2014;

WHEREAS, the said forest products, subject of donation, is specifically intended to augment the needed wooden beds for assigned COVID Isolation/Quarantine Facility located at LGU-NHA Housing Project Brgy. Dolores, Ormoc City;

WHEREAS, the Donee devoid of any ill-intent or purpose do hereby accept the abovementioned donation and expresses his thanks and gratitude for the generosity and liberality of the Donor;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, helps to maintain a COVID free environment of the City and henceforth, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of SP Member Benjamin S. Pongos, Chairman, Committee on Laws and Ordinances and SP Member Lalaine A. Marcos, Committee on Environment, Natural Resources, and Energy Conservation, severally seconded by SP Members Roiland H. Villasencio, Tomas R. Serafica, Nolito M. Quilang, Gregorio G. Yrastorza III, Peter M. Rodriguez, Esteban V. Laurente and Joan Marbie C. Simbajon; be it


