A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY 70 ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE NATIONAL IRRIGATION ADMINISTRATION (NIA)AND THE CITY GOVERNMENT OF ORMOC RELATIVE THE TO REMABI TATION AND IMPROVEMENT WORKS OF THE SERVICE ROADS OF BAO RIVER IRRIGATION SYSTEM.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated June 29, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) to be entered into by and between the National Irrigation Administration (NIA) and the City Government of Ormoc relative to the rehabilitation and improvement works of the Service Roads, a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, National Irrigation Administration (NIA) is a government owned and controlled corporation created under Republic Act No. 3601 as amended by Presidential Decree Nos. 552 and 1702 is hereinafter referred to as NIA;

WHEREAS, NIA is mandated to develop, rehabilitate, operate, and maintain irrigation facilities to improve irrigation services;

WHEREAS, the Bao River Irrigation System in Valencia, Ormoc City was one of the National Irrigation System in Region VIII to adapt the mandate to develop, rehabilitate, operate, and maintain irrigation systems facilities including the service roads and farm to market roads within its service area in Ormoc City;

WHEREAS, the service road within National Irrigation System under Bao River Irrigation System also serves as the passage of the commuters from Ormoc City and other Barangays in going to sitios (sub-barangays) and vice versa;

WHEREAS, the agency does not receive subsidy from the national government, hence Operation and Maintenance cost of Systems are funded out of its internally generated income, which causes poor maintenance of its facilities including the Service Roads if funds generated, is low;

WHEREAS, the residents of the barangays and other commuters utilizing the service roads of Bao River Irrigation System are adversely affected by the poor condition of this road:

Rodriguez and Joan Marbie C. Simbajon; be it


