A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ/OIC MAYOR/ACTING MAYOR THE AUTHORITY TO ENTER INTO AND SIGN THE DEED OF USUFRUCT BY AND BETWEEN THE CITY GOVERNMENT UNIT OF ORMOC CITY, AS AND THE SUPREME COURT PHILIPPINES, AS THE USUFRUCTUARY, PARCEL OF LAND WITH AN AREA OF ONE HUNDRED TWENTY EIGHT (128) SQUARE METERS AND THE BUILDING CONSTRUCTED THEREON LOCATED AT DBRERO ST., ORMOC CITY TO BE UTILIZED AS REGIONAL TRIAL COURT BRANCH 47, ORMOC CITY COURTHOUSE.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Endorsement Letter dated 30 June 2020 requesting for the passage of a Resolution granting the City Mayor or his representative the authority to enter into and sign the Deed of Usufruct (Deed) by and between the City Government Unit of Ormoc City and the Supreme Court of the Philippines for a parcel of land located at Obrero St., this City, to be utilized as Regional Trial Court (RTC) Branch 47;

WHEREAS, Section 455 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Local Chief Executive to represent the City in all its business transactions and sign in its behalf all x x x contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the OWNER is the owner in fee simple of a certain parcel of land with an area of 2,875 square meters, covered by Tax Declaration No. 01012-00022 with Property Index No. 155-04-001-21-071, a copy of the Tax Declaration is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, for and in consideration of liberality, the OWNER grants unto the USUFRUCTUARY, full right to the possession, use and enjoyment of a portion said parcel of land and the building constructed thereon for the benefit of the trial courts, the lot containing an area of ONE HUNDRED TWENTY-EIGHT (128) SQUARE METERS for the above cited purpose;

WHEREAS, upon the execution of the Deed, the usufruct over the Land and Building shall remain in full force for a period of THREE (3) years, renewable upon mutual agreement of the parties when the premises are needed and will be exclusively used by the USUFRUCTUARY as RTC Branch 47, a copy of the Deed is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, both parties share a common vision to achieve speedy, adequate, quality administration of justice, as well as effective and efficient public service particularly to the locals of this City;

WHEREAS, in a communication dated 19 June 2020 from the City Legal Office it stated therein that the attached Deed is not contrary to law, morals, good customs, public policy and public order;

WHEREAS, upon close and thorough review, this Sanggunian finds that the requested authorization to the City Mayor addresses the need of offices for other agencies of the government, because in the end, the services of such offices redound to the benefit of the public and the entire constituencies as a whole, aside from the fact, that it is mandated that all agencies and local government units shall have a shared responsibility – and thus, mutual support and cooperation is most expected – for the advancement of all the aspects of development, meriting this august Body's full support and favorable action;

Laurente, Jasper M. Lucero; Nolito M. Quilang, Joan Marbie C. Simbajon, Vincent L. Rama and Lalaine A. Marcos; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ/OIC MAYOR/ACTING MAYOR THE AUTHORITY TO ENTER INTO AND SIGN THE DEED OF USUFRUCT BY AND BETWEEN THE CITY GOVERNMENT UNIT OF ORMOC CITY, AS THE OWNER, AND THE SUPREME COURT OF THE PHILIPPINES, AS THE USUFRUCTUARY, FOR A PARCEL OF LAND WITH AN AREA OF ONE HUNDRED TWENTY EIGHT (128) SQUARE METERS AND THE BUILDING CONSTRUCTED THEREON LOCATED AT OBRERO ST., ORMOC CITY TO BE UTILIZED AS REGIONAL TRIAL COURT BRANCH 47, ORMOC CITY COURTHOUSE;

The SUPREME COURT OF THE PHILIPPINES, a government agency of the Republic of the Philippines, with principal office at Padre Faura Street, Ermita, Mania, represented in this Deed by Honorable JOSE MIDAS P. MARQUEZ, Court Administrator, pursuant to the Resolution of the Court En Bane in A.M. No.

dated hereinafter referred to as the "USUFRUCTUARY"

WITNESSETH:

WHEREAS, the OWNER is the owner in fee simple of a certain parcel of land with an area of 2,875 square meters, covered by Tax Declaration No. 01012-00022 with Property Index No. 155-04-001-21-071 with the following technical description:

WHEREAS, the OWNER issued Sangguniang Panlungsod Resolution No.

which transfers and conveys by way of USUFRUCT a portion of the above parcel of land with an area of ONE HUNDRED TWENTY EIGHT (128) SQUARE METERS and the Building constructed thereon located at Obrero St., Ormoc City in favor of the USUFRUCTUARY to be utilized as Regional Trial Court Branch 47, Ormoc City Courthouse;

WHEREAS, the OWNER expresses that it (i) is a registered owner in fee simple of the said lot and building subject of usufruct, (ii) the usufruct was not made with intent to defraud its creditors; (iii) it has reserved for itself sufficient area for the local government and for other appropriated government development projects; and, (iv) the land subject of usufruct is free from any liens and encumbrances;

WHEREAS, the OWNER grants unto the USUFRUCTUARY, full right to the possession, use and enjoyment of the said parcel of land and the building constructed thereon for the benefit of the trial courts for such period of time that the said trial courts use the said land for the administration and dispensation of justice;

WHEREAS, it is the basic policy of the USUFRUCTUARY to ensure the efficient and effective delivery of judicial services to the public; and,

WHEREAS, the OWNER and the USUFRUCTUARY share a common vision to achieve speedy, adequate, quality administration of justice, as well as effective and efficient public service particularly to the locals of Ormoc City:

NOW THEREFORE, the USUFRUCTUARY do hereby ACCEPTS the usufruct in favor of the Supreme Court of the Philippines for the use and benefit of the trial courts of Ormoc City and expresses its gratitude for the liberality and generosity of the OWNER.

NOW THEREFORE, for and in consideration of the foregoing premises and of the mutual covenants hereinafter contained, the parties agree as follows:

- 1. TERM. Upon the execution of this Deed, the usufruct over the Land and Building shall remain in full force for a period of THREE (3) years commencing on the date of this instrument. The term is renewable upon mutual agreement of the parties when the premises are needed and will be exclusively used by the USUFRUCTUARY as RTC Branch 47, Ormoc City Courthouse for the efficient administration of justice at Ormoc City;
- 2. The **OWNER** guaranteed the beneficial use and peaceful occupation of the land and Building by the **USUFRUCTUARY**;
- 3. The USUFRUCTUARY, before entering upon the enjoyment of the property, shall be obliged to make, after notice to the OWNER, an inventory of all the property, which shall contain an appraisal of the movables and a description of the immovable in the Building (should there be any). The USUFRUCTUARY, however, shall be excused from the obligation of giving security in accordance with Article 585 of the Civil Code:
- 4. The USUFRUCTUARY shall shoulder the expenses for electricity and water in the said Building;
 - It is understood that the OWNER shall install electric sub-meters for the USUFRUCTUARY. The monthly readings for the said sub-meter shall be undertaken jointly by the OWNER and representative of the USUFRUCTUARY.
- 5. The USUFRUCTUARY shall deploy security guard(s) for the areas of the Building subject of usufruct.
- The duties and obligations of the USUFRUCTUARY and the OWNER as provided for in the relevant provisions of the New Civil Code of the Philippines are deemed of the provisions of this Deed.
- 7. The USUFRUCTUARY shall maintain the property in clean and sanitary condition free from noxious odors, disturbing noises or other nuisances. The USUFRUCTUARY, its employees, agents or representatives, shall not in any manner cause damage or deface any part of the office space given in usufruct;
- 8. The pertinent provisions of the "Guidelines on the Occupancy, Use, Operation and Maintenance of the Halls of Justice" issued by the Supreme Court through the Resolution dated 23 October 2001 in A.M. No. 01-9-09-SC shall govern in the maintenance of the space allocated for the use of the Regional Trial Court; and,
- 9. The USUFRUCTUARY shall provide the materials recovery facility/three garbage receptacles (for biodegradable, non-biodegradable, and recyclable materials) in the Building subject of usufruct. It shall dispose all its garbage in accordance with the rules promulgated by the national or local government;


