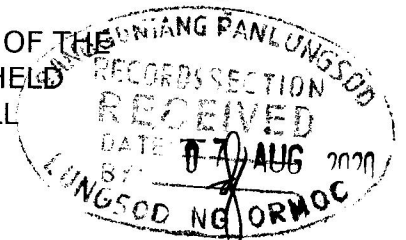

RESOLUTION NO. 2020-231

**A RESOLUTION APPROVING AND GRANTING
AUTHORITY TO THE OFFICE OF THE CITY HEALTH
OFFICER TO PURCHASE ONE (1) UNIT SERVICE
VEHICLE IN THE AMOUNT OF TWO MILLION
PHILIPPINE PESOS (PHP2,000,000.00).**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated July 16, 2020 respectfully endorsing the request of Dr. Edmund B. Kierulf, City Health Officer II, for the passage of a Resolution granting authority to purchase One (1) unit, Fifteen (15) seater, Diesel-fed Commuter Vehicle, for the amount of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00);

WHEREAS, the requested vehicle shall be used by the City Health Office, the primary arm of the Local Government Unit of Ormoc City that ensures accessible, affordable and quality health care, for daily transport of the Public Health Nurses, Rural Health Midwives, Doctors and other employees who will be deployed to the different areas under their jurisdiction as part of their response to the COVID-19 threat such as but not limited to contact tracing and monitoring of community isolation units;

WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated March 5, 2020 stating therein that the City Health Office has available funds for the purchase of the aforementioned vehicle in the amount of TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00) to be sourced from the CY 2020 General Fund-Capital Outlay for Motor Vehicles, a copy of said certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Sangguniang finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office most specifically in times of COVID-19 Pandemic, where they can immediately execute their response to the COVID-19 threat such contact tracing and monitoring of community isolation units which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;

WHEREFORE, on motion by SP Member Peter M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by Tomas R. Serafica, Gregorio G. Yrastorza III, Esteban V. Laurente, Joan Marbie C. Simbajon and Vincent L. Rama; be it



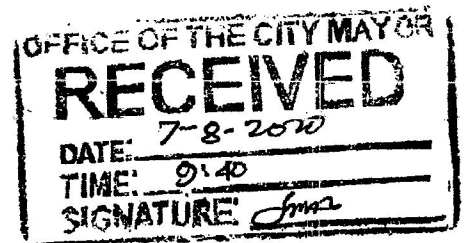


