

**RESOLUTION NO. 2020-236**

**A RESOLUTION APPROVING THE CY 2021 ANNUAL INVESTMENT PROGRAM (AIP) IN THE AMOUNT OF THIRTEEN BILLION EIGHT HUNDRED TWENTY-NINE MILLION SIX HUNDRED FIFTY-FIVE THOUSAND PHILIPPINE PESOS (PHP13,829,655,000.00) THEREBY ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 2, SERIES OF 2020.**

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated July 27, 2020 from the City Mayor Richard I. Gomez forwarding the City Development Council (CDC) Resolution No. 2, Series of 2020, entitled: "A RESOLUTION APPROVING THE CY 2021 ANNUAL INVESTMENT PROGRAM (AIP) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME", hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the CY 2021 AIP in the amount of THIRTEEN BILLION EIGHT HUNDRED TWENTY-NINE MILLION SIX HUNDRED FIFTY-FIVE THOUSAND PHILIPPINE PESOS (PHP13,829,655,000.00) involves priority projects, programs and activities to be implemented during the year which are expected to spur economic growth and development in the City of Ormoc.

WHEREAS, the CY 2021 AIP serves as the main reference in the preparation of the city's Annual Budget for CY 2021 and an expression of the comprehensive development plan of the city, the funding of which shall emanate from external/local sources, national government and other agencies;

WHEREAS, the lists of the proposed programs and projects comprising the CY 2021 AIP are hereto attached as Annex "B" and made an integral part of this resolution;

WHEREAS, the City Development Council (CDC) believes that all identified projects in the CY 2021 AIP are in conformity with the present needs of the city thus, vital to its continued progress and development, and it encompass the priority programs and services responsive to the needs of the Ormocanon people;

WHEREAS, this Sanggunian believes that the proposed AIP for CY 2021 deserves utmost support and prompt favourable consideration as it is consistent with the thrust of the city government to provide efficient public service and better quality of life to the Ormocanons;
