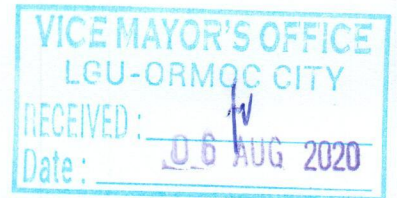
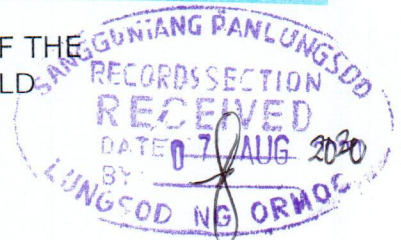

RESOLUTION NO. 2020-237

A RESOLUTION APPROVING THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 OF THE CITY OF ORMOC IN THE AMOUNT OF NINE HUNDRED SIXTY-SIX MILLION FOUR HUNDRED NINETY THOUSAND FIVE HUNDRED TWENTY-THREE PHILIPPINE PESOS AND FOURTEEN CENTS (PHP966,490,523.14) THEREBY ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 3, SERIES OF 2020.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated July 17, 2020 from the City Mayor Richard I. Gomez forwarding the City Development Council (CDC) Resolution No. 3, Series of 2020, entitled: "A RESOLUTION APPROVING THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME", a copy of said resolution is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Supplemental AIP involves a total investment of NINE HUNDRED SIXTY-SIX MILLION FOUR HUNDRED NINETY THOUSAND FIVE HUNDRED TWENTY-THREE PHILIPPINE PESOS AND FOURTEEN CENTS (PHP 966,490,523.14) for the priority projects, programs and activities to be implemented during the year which are expected to spur economic growth and development in the City of Ormoc;

WHEREAS, after thorough discussion, the City Development Council (CDC) believes that the identified projects and programs are vital to the continuous development of the city, necessary, and in accordance to the present needs of the Ormocanon community;

WHEREAS, this Sanggunian considers the proposed Supplemental AIP to be in line with the administration's thrust for the continued improvement and development of the city along with the vision of providing good quality of life to the Ormocanons through the delivery of efficient public service, and hence, it is deemed appropriate that the matter be accorded favorable action;

WHEREAS, this august Body considers the proposed Supplemental AIP for CY 2020 to be coherent with the thrust of the city government to provide effective and efficient public service to all Ormocanons, therefore, most deserving of prompt favorable action;






