A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN THE TERMS OF PARTNERSHIP (TOP) TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND THE DEPARTMENT OF HEALTH-EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT ANNUAL OPERATIONAL PLAN CY 2020. FOR THE

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated July 29, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or the Acting City Mayor the authority to enter into and sign the Terms of Partnership (TOP) to be executed by and between the City Government of Ormoc and the Department of Health-Eastern Visayas Center for Health Development for the Annual Operational Plan CY 2020. Further, requesting that this matter be treated as URGENT, a copy of the TOP is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, the Department of Health-Eastern Visayas Center for Health Development, a regional government agency created and existing under the laws of the Republic of the Philippines is hereinafter referred to as "DOH-EV CHD";

WHEREAS, in a Letter dated June 8, 2020, the DOH-EV CHD informed the Office of the City Mayor that the City Government of Ormoc is entitled to a fixed tranche allocation for CY 2020 amounting to One Million (Php1,000,000.00) Pesos in line with the amendment on the 2020 Fixed Tranche Computation Department Order No. 2019-0390 "Submission of Work and Financial Plan (WFP) CY 2020. The fixed tranche allocation shall be transferred upon signing of the Terms of Partnership (TOP), a copy of the Letter is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, an Indorsement dated June 25, 2020, the City Health Department Ormoc City forwarded to the Office of the City Mayor a copy of the draft Terms of Partnership to be entered into by and between the Local Government Unit of Ormoc City and the Department of Health Regional Office 8 (Eastern Visayas Center for Health Department), a copy of the Indorsement is hereto attached as "ANNEX C" and made an integral part hereof;

WHEREAS, in an Opinion dated July 2, 2020, the City Legal Office finds the provisions of the TOP as not contrary to law, public policy, morals, or order. Further, recommending that the agreement be referred to the appropriate finance office considering that a good number of the terms relate to said office, a copy of the Opinion is hereto attached as "ANNEX D" and made an integral part hereof;

WHEREAS, in a Letter dated July 29, 2020, the Office of the City Accountant poses no objection to any concerning provision in the subject captioned Partnership Agreement, a copy of the letter is hereto attached as "ANNEX E" and made an integral part hereof;

WHEREAS, Section 11, Article XIII of the 1987 Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, RA 7160 otherwise known as the 1991 Local Government Code mandated the devolution of the delivery of health and facilities as one of the basic functions and responsibilities of all Local Government Units (LGUs) at all levels;

WHEREAS, Section 22 of RA 11223 otherwise known as the Universal Health Care (UHC) Act of 2019 mandated the National Government to make available commensurate financial and non-financial matching grants, including capital outlay, human resources for health and health commodities, to improve the functionality of province-wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans;

WHEREAS, the Formula One Plus for Health with its tagline "Boosting Universal Health Care" is the strategic framework for Health Sector Reform to attain the goals outlined by the Philippine Government in the Philippine Development Plan, the Sustainable Development Goals, and the Ambisyon Natin 2040, specifically for the health sector, goals of better health outcomes, more equitable health care financing, and more responsive health system;

WHEREAS, the City of Ormoc has agreed to implement health sector reforms consistent with the Universal Health Care Act and the Formula One Plus for Health and has proven its capacity to utilize investment and sustain the reform process, among others;

WHEREAS, the Local Investment Plan for Health (LIPH) is the key instrument in forging the Department of Health (DOH) and Local Government Unit (LGU) partnership to carry out the Formula One Plus for Health , and technical assistance from the DOH shall be consolidated and matched with the needs outlined in the Local Investment Plans for Health;

WHEREAS, the City, in partnership with their component LGUs, have agreed to fund and implement the programs, projects, and activities under their respective LIPHs/AOPs through their own financing source, and through available funds and resources form the DOH, and development partners, coordinated with the DOH;

TERMS OF PARTNERSHIP

(Annual Operational Plan CY 2020)

KNOW ALL MEN BY THIS PRESENTS:

This Terms of Partnership (TOP) is made and entered by and between:

The Department of Health – Eastern Visayas Center for Health Development, a regional government agency created and existing under the laws of the Republic of the Philippines with principal office address at Government Center, Brgy. Candahug, Palo, Leyte herein represented by the Director IV, MINERVA P. MOLON, MD, MPH, FPPA, CESO III and hereinafter referred to as the "DOH-EV CHD";

and

WITNESSETH

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution provides, among others, that the State shall adopt an integrated and comprehensive approach to health development, which shall endeavor to make essential goods, health and social services available to all people at affordable cost;

WHEREAS, Republic Act 7160 otherwise known as the 1991 Local Government Code mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all Local Government Units (LGUs) at all levels;

WHEREAS, Section 22 of hepublic Act 11223 otherwise known as the Universal Health Care (UHC) Act 2019 mardated the National Government to make available commensurate financial and non-financial matching grant incheding capital outlay, human resources for health and health commodities, to improve the functionality of province wide and city-wide health systems, provided that the grants shall be in accordance with the approved province-wide and city-wide health investment plans.

Where AS, the Fourmula Ope Plus for Health with its tagline "Boosting Universal Health Care" is the strategic framework for Health Sector Reform to attain the goals outlined by the Philippine Development Plan, the Sustainable Development Goals, and The Ambisyon Nation 2040, specifically for the health sector, goals of better health outcomes, more equitable health care financing, and more responsive health system;

WHEREAS, the City of Ormoc has agreed to implement health sector reforms consistent with the Universal Health Care Act and the Fourmula One Plus for Health and has proven its capacity to utilize investment and sustain the reform process, among others;

WHEREAS, the Local Investment Plan for Health (LIPH) is the key instrument in forging the Department of Health (DOH) and Local Government Unit (LGU) partnership to carry out the Fourmula One Plus for Health, and technical assistance from the DOH shall be consolidated and matched with the needs outlined in the Local Investment Plans for Health; and whereas the implementation of the LIPH is translated through the Annual Operation Plans;

WHEREAS, the CITY, in partnership with their component LGUs, have agreed to fund and implement the programs, projects and activities under their respective LIPHs/AOPs through their own financing source, and through available funds and resources from the DOH, and development partners, coordinated with the DOH.

WHEREAS, the City of Ormoc has prepared its 2020-2022 LIPH, and 2020 Annual Operational Plan (AOP), which have been reviewed by the City and DOH-EV CHD Appraisal Committee, and modified as necessary following the recommendations of the above;

NOW THEREFORE, in consideration of the foregoing premises, and by way of formalizing and confirming the commitment of the City and the DOH-EV CHD, the parties hereby agree to enter into agreement in accordance with the terms and conditions hereunder set forth:

ARTICLET IMPLEMENTATION ARRANGEMENT

1.1 Program Coverage

This agreement shall cover the management and implementation of the approved 2020 AOP (Annex), and shall focus on the achievement of improved local health system performance consistent with the UHC Act and Fourmula One Plus For Health.

1.2 Roles and Responsibilities

A. The City shall:

The City hereby adheres to an integrated and phased implementation of the VHC Act and 2020-2022 LIPH, as embodied in the approved 2020 AOP, and commits to the principles and conditions set forth and to this end, shall:

- Issue executive instruments or local legislations, whenever necessary implementation of the UHC Act and 2020-2022 LVPH, through the approved 2020 AOP;
- 2. Secure the participation and cooperation of its component LGUs in carrying out local initiatives or activities pursuant to a city-wide implementation of the UHC Act and 2020-2022 LIPH, through the approved 2020 AOP, to include but not limited to:

2.1 Secure increased, better and sustained financing for health from DOH, PhilHealth and LGU appropriations;

2.2 Assure the quality and attordability of health goods and services through DOH licensing and PhilHealth accreditation;

2.3 Ensure access it and availability of essential and basic health packages by matching its catchment population to appropriate Primary Care Provider Network and through effective referral systems:

2.4 Improve performance of the health system, measured through accurate, sensitive and timely evidemiologic surveillance systems and other monitoring and evaluation systems;

Conduct proactive, effective and evidence-based health promotion programs or campaigns;

- 2.6 Provide timely, effective and efficient preparedness and response to public health emergencies and disasters;
- Allocate, release and use, together with its component LGUs, funds that are necessary for the city-wide implementation of the approved 2020 AOP;

3.1 Re guided by the approved 2020 AOP in the disbursement of funds;

3.2 Il stablish and maintain a Trust Account in a government depository bank to be known as DOH Health Fund" for the fund releases, provided that separate ledgers and/or sub-ledgers shall be maintained by the City for each and every type of fund transfer;

3.3 Ensure all funds, including grants proceeds and counterpart, shall flow directly to the City Trust Fund, as appropriate, and/or shall be automatically appropriated for the implementation of the approved 2020 AOP;

3.3.1 Assure that adequate funds shall be made available to support/enable the Pillars of the Fourmula One Plus For Health and the progressive realization of UHC;

3.4 Ensure compliance with existing COA rules and regulations.

Take all steps in meeting the technical requirements and operational conditions that are prerequisites for the release of grant allocations for specific programs;

4.1 Prepare and submit, in a timely manner/within the deadline set/agreed, to the DOH-EV CHD Monitoring Reports and Fund Utilization/Liquidation Reports;

4.2 Upgrade/enhance the administrative and operational capabilities of its local health facilities to conform to the existing accreditation and licensing standards;

4.3 Be responsible for the compliance with all applicable procedures, rules and regulations, environmental and zoning laws and regulations, and that all necessary licenses and permits are obtained prior to the commencement of civil works;

- Manage the program resources and ensure the delivery of inputs (e.g. rehabilitation works, equipment, ruman resource for recaute deproyment, commodutes, capacity outleing, etc.) to the lower levels of local government to produce required outputs;
- 6. Contribute to and facilitate monitoring evaluation and audit activities that shall be conducted in the course of the program;
 - 6.1 Submit the accomplishment/monitoring reports required by the DOH in a timely manner/within the deadline set/agreed.
- B. The Department of Health Eastern Visayas Center for Health Development (DOH-EV CHD) shall:
- 1. Coordinate/facilitate the support from National Government Agencies (NGAs) and their instrumentalities, and development partners, to the City for the implementation of the approved 2020 AOP;
 - 1.1 Maintain stewardship function over DOH funds provided to the City-wide Health System (CWHS) to support attainment of goals and objectives of the approved 2020 ACF
- 2. Issue the necessary policies to mobilize its offices to assist in the city-wide implementation of the approved 2020 AOP;
- Advocate for the issuance of local executive policies or legislative enactments by the LGUs in the CWHS that are necessary for the implementation of the approved 2020 AGP;
- 4. Deliver the necessary technical assistance (TA) to the City
 - 4.1 Provide logistical and technical support to the City for the overall planning, management, coordination and implementation of priority activities and programs;
 - 4.2 Assist in building the capacity of the CWHN
- 5. Undertake monitoring of the implementation of the approved 2020 AOP;
- 6. Facilitate and arrange the provision and release of financing grants within the DOH-EV CHD Director's authority and control:
 - 6.1 Ensure the timely release of DOH-EV CHD funds to the City or to component LGUs of the CWHS, when repersally, based on the verified physical, financial, and technical accomplishment reports,
 - 6.2 Release the funds and commodities to the City based on the technical guidelines issued by
 - 6.3 Authorize the City to manage the DOH cash transfers and support in kind (commodities) as it implements the approved 2020 AOP to produce the deliverables and outputs indicated in this Agreement;
 - 6.4 Ensure compliance with existing COA rules and regulations.

ARTICLE II RESOURCES AND FINANCIAL ARRANGEMENTS

- 1 Resources from National Government and Local Government Unit
- 1.1 The City shall receive an estimated allocation of <u>PhP 43,207,788,62</u> support (financial and non-financial grants) from the National Government-DOH for the implementation of the approved 2020 AOP, details of which is shown in Table 1.
- 1.2 Program Funding

The implementation of the approved 2020 AOP shall be funded by various sources which may include the following: 1) Cash transfers from the DOH-EV CHD, 2) Support in kind or commodities from the DOH regular budget of the Central Office, coursed through the DOH-EV CHD, 3) PhilHealth payments, 4) Local Government Unit Funds, and 5) Other funds identified by DOH-EV CHD and LGU, including funds from development partners, and other stakeholders.

2.2 Financial Arrangements

2.2.1 Use of Fixed Tranches: Heath Systems Strengthening

2.2.1.1 LIPH/AOP development, planning, advocacy to consultations with key stakeholders, appraisal, monitoring, program implementation review;

2.2.1.2 Geographically Isolated and Disadvantaged Areas (GiDA), Indigenous Cultural Communities/Indigenous Peoples (ICC/IP)/ Urban Poor activities/projects, such as but not limited to, community profiling/GiDA information system, culture sensitivity orientation, grants for project proposals, to improve availability and access to health care through the integrated CWHS;

2.2.1.3 CWAS integration activities such as, but not limited to, establishment/strengthening of referral systems, inventory facility mapping, establishment of management/technical groups, profiling of families, mentoring of health care service provision;

2.2.1.4 Governance and leadership activities;

2.2.1.5 implementation and the use of LGU Scorecard, including advocacy and recognition of those with exemplary performance;

2.2.16 For Highly Urbanized Cities/Independent Component Cities: Data collection for equity assessment/measurement; health equity interventions;

2.2.1.7 Raningsy Health Workers (BHW) activities;

2.2.1.8 Documentation of best practices;

2.2.1.9 Any unutilized incorporated/ transferred funds may be reprogrammed to other Local Health Systems Development (LHSD) activities, as recommended by the DOH-EV CHD LIPH Coordinator, subject to existing budgeting, accounting and auditing rules and regulations;

2.2.2 The LGU counterpart shall be based on the approved 2020 AOP which is included by the City & its component LGUs in their Annual Investment Plans (AIP), as per DILG, NEDA, DBM and DOF Joint Memorandum Circular No. 1, Series of 2016: Updated Guidelines on the Harmonization of Local Planning, Investment Programming, Resource Mobilization, Budgeting, Expenditure Management, and Performance Monitoring and Coordination in Fiscal Oversight;

2.2.3 Transfer/use of funds or commodities shall adhere to the DOH guidelines for the Work and Financial Plan and other technical guidelines on the release and transfer of resources from the National Government to City Local Government Units, and specify the sources and uses of the resources including the expected outputs/deliverables:

2.2.4 The LGU shall submit a copy of "Certification by the Accountant that funds previously transferred to the Implementing Agency (IA) has been liquidated and accounted for in the books" (per COA Circular 2016-002 dated 31 May 2016) to the DOH-EV CHD before the end of Quarter 2 of the succeeding year and to refund expenditures disallowed by audit;

2.2.5 In the event that the LGU fails to liquidate the previously transferred DOH funds within the prescribed timelines, the DOH shall manage or co-manage the funds or return the same to the National Treasury in accordance with existing accounting and auditing rules and regulations. Moreover, fund utilization of the LGU will be one of the bases for the increase/decrease in the computation of its Fixed Tranche for the succeeding years.

This Agreement shall be terminated upon satisfactory fulfillment of all the terms and conditions embodied herein but not later than June 2021. Any modification or amendments to this Agreement as proposed by either party shall mutually be agreed upon in writing by all the parties hereto


