### II. PURPOSE

This action plan was formulated in order to come up with a detailed and prescribed method in our campaign against all forms of criminality in our area of responsibility particularly on theft and robbery incidents and to have a definite and persistent approach to minimize if not eradicate the prevalent crimes in the city.

### III. SITUATION

Based on record, Theft and Robbery incident are the most prevalent crimes in Ormoc City. Perpetrators are victimizing local constituents and those travelers visiting the city. Their modus operandi is Akyat Bahay, Salisi, Pickpocketing, Snatching, Shoplifting, etc. Perpetrators usually assess the would-be victims by looking at the opportunity and suitable timing to execute their criminal act.

In this instance, victims and the police found hard time to identify the perpetrator which led to non-filing of appropriate charges in court. On the other hand, the police efforts in arresting the suspect and the recovery of the stolen items turned futile as the victim is not interested to file legal suit against the suspect. Hence, the case remains unsolved.

This situation will incite the perpetrator's desire to repeatedly commit the same nefarious act. There are also possibilities that other criminal minded persons may carry out the same act if the police and the community will not take positive action to curb this social menace.
