A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGUORMOC), THROUGH THE CITY HEALTH DEPARTMENT, WITH SAN LORENZO RUIZ COLLEGE OF ORMOC, INC. (SIRC) FOR THE AFFILIATION WITH THE LGUHEALTH CENTERS AS TRAINING AREA FOR SLRC BACMELOR OF SCIENCE IN NURSING (BSN) STUDENTS.

WHEREAS, an indorsement was forwarded to this august Body from the Office of the City Mayor dated August 18, 2020 endorsing the request for issuance of a resolution granting the City Mayor or his representative the authority to enter into and sign the Memorandum of Agreement (MOA) with San Lorenzo Ruiz College of Ormoc Inc. (SLRC) for the affiliation of its Bachelor of Science in Nursing (BSN) Course with the City Health Department (CHD). A copy of the said MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, the provisions of DOH Administrative Order No. 9-C, series of 1997, implementing Administrative Order No. 5, series of 1996 provides for the rules and regulations which govern the affiliation and training of students in government hospitals and other health facilities;

WHEREAS, pursuant to the provisions of Section 455, Paragraph (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which authorizes the City Mayor to represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, such other documents upon authority of the Sangguniang Panlungsod concerned pursuant to law or ordinance;

WHEREAS, the signing of the MOA signifies the party's commitment to continually uphold quality education and advance the learning of the students by exposing them to real-life contexts and situations, thus, ensuring strong advocacy for high quality education that will redound to better provision of social services and all its related programs for the City's constituents;

WHEREAS, the City's Health Centers are directly engaged in rendering various health related services in their respective communities. Hence, the immersion experience in the student's education magnifies the perspective on the concrete health conditions among the various sectors in the population which would further enhance the educational experience of the students;

WHEREAS, this august Body sees the need for the signing of the MOA relative to the contract of affiliation in order to help BSN students gain enough knowledge and experiences in the field of medical services and to help address the needs of our constituents;

WHEREAS, the said MOA defines the terms and conditions intended for the affiliation and training of SLRC BSN intern students at the LGU Health Centers so as to ensure high quality education for both undergraduate and prospective nursing students;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same;

WHEREAS, this Sanggunian, upon thorough review, finds that the same is extremely favorable and advantageous to the institution and the communities that both parties are serving and therefore, is most deserving of this august Body's prompt and favorable consideration;

- Allow only students in the field practice area when accompanied by a clinical instructor from affiliating school;
- e. Allow the nursing students to do hands-on care to clients in the community within the scope of their responsibilities, under the supervision of their clinical teachers;
- f. Allow nursing students to have delivery cases of all the District Health Centers of the city government of ormoc.

That San Lorenzo Ruiz College of Ormoc shall:

- a. Abide by the rules and regulation of the Department of Health and the City Health Office regarding the affiliation and training of students, as well as the implementation of health programs;
- b. Pay the standard affiliation fees per sindem to the City Health Office in such amount which shall be treated as trust fund and utilized in accordance with A.O. 5-A, s 1996 of the Department of Health.
- c. Provide clinical instructors who will supervise the students assigned at the health units;
- d. Provide the transportation of nursing students to and from the District Health Centers;
- e. SLRC shall pay or replace damages, breakages or losses by faculty and students at the health centers; and
- f. Be responsible for every action that maybe committed by their students.
