## RESOLUTION NO. 2020-269

A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF THE ORMOC WOMEN VENDORS ASSOCIATION (ORWVA).

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty – day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of an application for accreditation of the aforementioned civil society organization;

WHEREAS, ORWVA, duly registered with Department of Labor and Employment on 24 January 2019, is an organization of women seeking to promote moral, social and economic well-being of all its members through the conduct of seminars and trainings on product development workshops;
