## RESOLUTION NO. 2020-288

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) TO BE MADE AND EXECUTED BY EDGAR PALUGOD AND EVANGELINE T. PALUGOD, HEREIN REFERRED TO AS "DONORS" IN FAVOR OF CITY GOVERNMENT OF ORMOC, REFERRED TO AS "DONEE", FOR THE THREE (3) PARCELS OF LAND THAT ARE BEING USED AS ROAD LOTS.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated December 4, 2019 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor to accept and sign the Deed of Donation (DOD) to be made and executed by Edgar Palugod and Evangeline T. Palugod, herein referred to as "Donors" in favor of the City Government of Ormoc, herein referred to as "Donee", for the three (3) parcels of land that are being used as road lots, a copy of the Deed of Donation is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Opinion dated December 3, 2019, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City, a copy of the Opinion is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, the donors are the owners of three (3) parcels of land situated in the City of Ormoc covered by TCT No. TH-624, TCT No. TH-635, and TCT No. TH-636 respectively, copy of the TCTs are hereto attached as "ANNEX C" and made an integral part hereof;

WHEREAS, the City Engineering Office has forwarded a copy of the Sketch Plan of the aforementioned parcels of land which is the subject matter of the Deed of Donation all located at Barangay San Pablo, Ormoc City, a copy of the said Sketch Plan is hereto attached as Annex "D" and made an integral part hereof;

WHEREAS, the Donors recognize and support the mandate of the Donee to provide basic services to its residents;

WHEREAS, the Donors desire to assist the Donee and give further impetus to its programs;

WHEREAS, the Donors hereby hereby transfer and convey unto the Donee, by way of donation, all of their respective rights and interests over the abovementioned properties, together with all the improvements thereon, unto the Donee, free from all liens and encumbrances;

WHEREAS, the Donee does hereby accept the foregoing donation of the abovementioned properties for which it expresses the sincerest appreciation and gratitude for the kindness and liberty shown by the Donors;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, facilitates the ongoing developmental progress of the City and henceforth, deserving of this august Body's prompt and favorable consideration;

Villasencio, Chairman, Committee on Public Properties, severally seconded by SP Members Tornas R. Serafica, Jasper M. Lucero, Joan Marbie C. Simbajon, Lalaine A. Marcos and Peter M. Rodriguez; be it
