

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated September 11, 2020 respectfully requesting for the passage of a Resolution granting authority to purchase Four (4) units brand-new service vehicle/s for the City Mayor's Office (CMO), City Health Department (CHD) and Environment & Natural Resources Office (ENRO) for a total amount of Five Million Nine Hundred Thousand Philippine Pesos (Php5,900,000.00);

WHEREAS, the requested vehicles shall be for the efficient execution of business operations and/or transactions of the aforementioned offices;

WHEREAS, to recall this Sanggunian approved Appropriation Ordinance No. 2020-001 otherwise known as the 2020 Annual Budget of the City of Ormoc enacted on December 10, 2019 approving therein a total budget of Twenty-two Million Four Hundred Thousand Philippine Pesos (Php22,400,000.00) under the General Fund intended for Motor Vehicle Purchases;



WHEREAS, the City Accountant and the City Budget Officer issued a Certificate of Availability of Funds dated September 4, 2020 stating therein that the amount of Five Million Nine Hundred Thousand Philippine Pesos (Php5,900,000.00) for the said purchase/s is deemed available and is sourced from the CY 2020 General Fund, a copy of the certification is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting offices and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;


