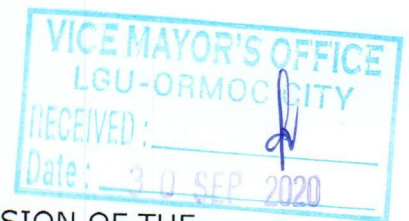

**A RESOLUTION AFFIRMING AND FAVORABLY
ENDORISING THE FOOD ASSISTANCE AMOUNTING TO
ONE HUNDRED THIRTY-SEVEN MILLION SIX
HUNDRED THOUSAND PHILIPPINES PESOS (PHP
137,600,000.00) AS RELIEF GOODS FOR COVID-19
AFFECTED HOUSEHOLDS IN ACCORDANCE WITH
DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)
LOCAL BUDGET CIRCULAR NO. 128 AND THE RA
11494 (BAYANIHAN TO RECOVER AS ONE ACT).**

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated September 25, 2020 from the City Mayor Richard I. Gomez requesting for an issuance of a resolution favorable endorsing Programs, Projects and Activities (PPAs) of LGU Ormoc relative to measures for the containment and prevention of the COVID-19, in accordance with Section 3.1.8 (Food Assistance and other relief goods for affected households) of Local Budget Circular No. 128 dated September 17, 2020 as per RA 11494 otherwise known as The Bayanihan to Recover as One Act amounting to One Hundred Thirty Seven Million Six Hundred Thousand Philippines Pesos (Php137,600,000.00);

WHEREAS, President Rodrigo Duterte signed into law last September 11, 2020 Republic Act No. 11494 otherwise known as the Bayanihan to Recover as One Act (Bayanihan 2) as the government's second coronavirus pandemic relief measure meant to serve as the country's defense against health and economic problems stemming from the COVID-19 outbreak;

WHEREAS, under Section 4(q) of the aforementioned Act, PHP1,500,000,000.00 was appropriated to the Local Government Support Fund (LGSF) to provide financial assistance to Local Government Units (LGUs) in their local anti-COVID efforts;

WHEREAS, the DBM issued Local Budget Circular No. 128 providing the guidelines on the release and utilization of the aforesaid funds;

WHEREAS, under Section 3.1.8 of the aforesaid circular, the appropriated amount of PHP1,500,000,000.00 can be utilized for food assistance and other relief goods for affected households;

WHEREAS, the amount is to be expended for the purchase of sacks of rice as food assistance to 64,000 households of Ormoc City as indicated in the LGSF COVID-19 Assistance to LGUs Project Proposal from the City Planning and Development Office, herein attached as Annex "A" and made integral part hereof;

WHEREAS, one of the requirements for the release of Local Government Support Fund (LGSF)-Covid-19 Financial Assistance is a Sangguniang Panlungsod Resolution endorsing the projects being proposed for implementation;

WHEREAS, this august Body considers the proposed COVID-19 Related Programs, Projects and Activities (PPAs) to be coherent with the administration's thrust for the mitigation of COVID-19 situation and in line with the city's direction to provide full assistance and support to all affected households during this time of pandemic, hence, it is deemed appropriate that the matter be accorded favorable action;





LGSF COVID-19 ASSISTANCE TO LGUs PROJECT PROPOSAL

Project Program/ Activity Title	Food Assistance (Rice)
Total Budgetary Requirement	Php 137,600,000.00 Php 2,150.00 (per sack) x 64,000 households = Php 137,600,000.00

Rationale	COVID-19 pandemic has brought major disruption in our health system and economy. As the number of cases and the fear of contagion have spread, confinement measures were imposed by national and local government units. To follow the health protocols, physical distancing, and limitations on the number of the workforce were facilitated. In other provinces, they even adopted full or partial lockdown measures to prevent transmission of the virus. In Ormoc City, the pandemic led to certain economic challenges that triggered the loss of livelihood and income; even constraints in financial resources. One of the consequences of the COVID-19 was the reduction of working hours and restrictions on mobility since the city is still imposing strict border control to prevent local and community transmission. These conditions have a corresponding risk that affects the people both physically and psychologically.
Program Objective	The City has been under strict community quarantine since March 15, 2020. Most affected by this pandemic were the unemployed and poorest people who were struggling to put food in the table and afford basic hygiene kits to stay protected from COVID-19. As an emergency response to the pandemic, this program will be implemented to provide and distribute 1 sack of rice to every household in Ormoc City as food assistance.
Implementation Process	The City Social Welfare and Development Office will be the implementing office to facilitate the rice distribution through the barangay. The barangay will be the one to distribute based on the validated household list.
