

**RESOLUTION NO. 2020-320**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY  
MAYOR, RICHARD I. GOMEZ OR THE ACTING CITY  
MAYOR TO ENTER INTO AND SIGN A MEMORANDUM  
OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE  
LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC),  
WITH THE DEPARTMENT OF EDUCATION - ORMOC  
CITY DIVISION FOR THE ESTABLISHMENT OF THE  
PROPOSED SALVACION NATIONAL HIGH SCHOOL.**

WHEREAS, an indorsement was forwarded to this august Body from the Office of the City Mayor dated September 25, 2020 endorsing the request for issuance of a resolution granting the City Mayor or his representative the authority to enter into and sign the Memorandum of Agreement (MOA) with the Department of Education for the establishment of the proposed Salvacion National High School. A copy of the said MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, there is a need for additional schools to accommodate the increasing number of high school students in the City. The request for the establishment of the said high school is also consonant to the thrust of DEPED Division Office to decongest New Ormoc City National High School (NOCNHS) that is currently challenged with overcrowding of students;

WHEREAS, the Department of Education - Schools Division of Ormoc City is in the process of securing, finalizing, and consolidating pertinent documents for the establishment of Salvacion National High School to operate independently from Liloan National High School;

WHEREAS, pursuant to Section VI (B) of DepEd Order No. 40, series of 2014, the applicant school must be able to submit a duly notarized MOA between DepEd represented by the SDS and LGU represented by the City Mayor as part of the documents required for establishment of a public school;

WHEREAS, on June 30, 2020, the 15<sup>th</sup> Sangguniang Panlungsod ng Ormoc passed Resolution No. 2020-189 entitled: "A RESOLUTION EXPRESSING THE SUPPORT OF THE CITY GOVERNMENT OF ORMOC ON THE ESTABLISHMENT OF SALVACION NATIONAL HIGH SCHOOL IN BARANGAY SALVACION, ORMOC CITY AND THE COMMITMENT TO SUPPORT THE OPERATION OF THE SCHOOL IN THE NEXT FIVE (5) YEARS OR UNTIL SUCH TIME FUNDS NEEDED ARE INCORPORATED IN THE NATIONAL BUDGET";

WHEREAS, the City Legal Office has reviewed the MOA and recommends the same for the endorsement to the 15<sup>th</sup> Sangguniang Panlungsod for appropriate action provided that the said undertaking is subject to the availability of funds;

WHEREAS, this august Body sees the MOA in line with the thrust of the City Government of Ormoc to open more high schools and make education accessible and affordable to the communities especially the poor and that the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the ends of the same;

WHEREAS, upon close and thorough review, this Sanggunian finds the request not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the people of Ormoc as it seeks to improve the quality of education through decongestion of New Ormoc City National High School and makes education more accessible to the communities and encourage the students in the communities surrounding Barangay Salvacion to continue with their studies so therefore, most deserving of this august Body's full support and affirmative action.

WHEREFORE, on joint motion of SP Member Nolito M. Quilang, Chairman of the Committee on Education, and SP Member Benjamin S. Pongos, Jr., Chairman of the Committee on Laws and Ordinances, severally seconded by SP Members Gregorio G. Yrastorza III, Joan Marbie C. Simbajon, Esteban V. Laurente, Tomas R. Serafica, Vincent L. Rama, Roiland H. Villasencio and Peter M. Rodriguez; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR, RICHARD I. GOMEZ, OR THE ACTING CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF EDUCATION – ORMOC CITY DIVISION FOR THE ESTABLISHMENT OF THE PROPOSED SALVACION NATIONAL HIGH SCHOOL;



## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This memorandum of Agreement executed by and between:

Department of Education Division of Ormoc City, a government office under the Department of Education (DepEd), with principal office at Narra Street, Brgy. Don Filipe, Ormoc City, represented herein by its Officer-in-Charge, Office of the Schools Division Superintendent, Mrs. Lani H. Cervantes, CESO VI, hereinafter referred to as "DepEd".

- and -

City of Ormoc, a Local Government Unit (LGU) created under the Philippine laws, with principal office at Aunubing Street, Brgy. Cogon, Ormoc City, Leyte, represented herein by Hon. Richard I. Gomez, hereinafter referred to as "LGU";

### WITNESSETH -

**WHEREAS**, the DepEd Division of Ormoc City, is in need of additional secondary school, particularly within the catchment area of Brgy. Salvacion, Ormoc City, to accommodate 246 or more prospective enrollees;

**WHEREAS**, the establishment of the proposed **SALVACION NATIONAL HIGH SCHOOL** is considered an urgent need in the City of Ormoc as indicated in the project feasibility;

**WHEREAS**, the City of Ormoc agrees to be a counterpart of DepEd in the establishment of the proposed school;

**NOW THEREFOR**, for and in consideration of the terms and conditions hereinafter set forth, the parties hereby agree to the following provisions:

#### 1. ROLES AND RESPONSIBILITIES OF DepEd

1.1 The DepEd shall ensure the issuance of DepEd School ID in the name of **SALVACION NATIONAL HIGH SCHOOL**;

1.2 The DepEd shall spearhead the implementation of the school's education curriculum;

1.3 The DepEd shall work for the school's funding requirements for Personnel Services, maintenance and Other Operating Expenses, and Capital Outlay in the General Appropriations Act, and the subsequent issuance of Agency Code;

1.4 The DepEd shall request for the creation of vital positions, both teaching and non-teaching, to the Department of Budget and Management (DBM), through the Regional and Central Offices;

1.5 The DepEd shall ensure the designation of an Officer-in-Charge of the **SALVACION NATIONAL HIGH SCHOOL**, and eventually the appointment of a School Head who possesses the necessary qualifications pursuant to DepEd, DBM and CSC applicable rules and regulations; and

1.6 The DepEd shall monitor the operation of **SALVACION NATIONAL HIGH SCHOOL**.

**2. ROLES AND RESPONSIBILTIES OF THE LGU**

2.1 The LGU shall provide funds for the SALVACION NATIONAL HIGH SCHOOL, among others, the following:

- 2.1.1 Construction of the new school building/s;
- 2.1.2 Procurement of educational facilities, furniture and instructional materials;
- 2.1.3 Operation and maintenance for at least five (5) years or until such time when funds for the purpose are incorporated in the national budget.

**3. OTHER CONDITIONS OF THE MOA**

3.1 This MOA does not in any way prevent the parties from entering other stipulations as may hereafter be agreed to by the said parties ; and

3.2 No part of portion of this MOA shall be amended or modified without the written approval of the parties hereto.

**4. FINAL PROVISIONS**

This MOA shall be valid upon signing by both parties and shall be effective for a period of 5 years from the date of signing, or until such time that sufficient funding is provided for in the General Appropriations Act in favor of SALVACION NATIONAL HIGH SCHOOL.


