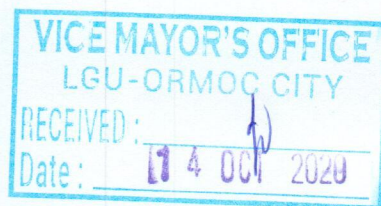
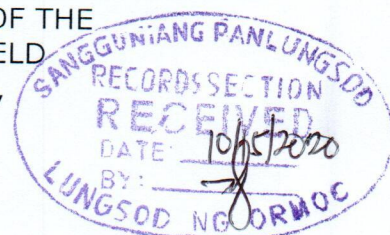

RESOLUTION NO. 2020-01 ENTITLED: "A RESOLUTION  
APPROVING THE CITY NUTRITION ACTION PLAN  
2020-2022."**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated October 8, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution adopting the attached City Nutrition Action Plan 2020-2022. This is to ensure that all nutrition programs in this City are properly in place for its implementation, a copy of said plan is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, The City Nutrition Committee approved the said plan through a Resolution No. 2020-01 dated September 25, 2020 entitled: "A RESOLUTION APPROVING THE CITY NUTRITION ACTION PLAN 2020-2022", a copy of said Resolution is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that "The State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, Article XIII, Section 11 of the 1987 Constitution provides that "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential Goods, Health, and other Social Services available to all people at affordable cost";



WHEREAS, the Local Government Unit of Ormoc (LGU-Ormoc) is a political subdivision mandated to assist the government in improving the health, safety, and the welfare of the people of Ormoc;

WHEREAS, Executive Order No. 03, Series of 2017 mandated the Nutrition Committee to ensure the effective implementation of the nutrition programs of the City of Ormoc ;

WHEREAS, per DILG Memorandum Circular No. 2018-42, series of 2018, entitled: " Adoption and Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022", LGUs are tasked to ensure the formulation, or if existing, revision or updating of the Local Nutrition Action Plan (LNAP) to include programs, projects and activities that converge in families of the nutritionally vulnerable individuals";

WHEREAS, the Ormoc City Nutrition Committee, as part of its duties and functions, is tasked to formulate and implement local food and nutrition policies, plans and intervention for nutrition improvement, in pursuance of the above memorandum;

WHEREAS, the goal of the City's Action Plan is to improve the nutritional status of pre-school children and school children through an integrated and comprehensive approach that shall serve as a guide for all concerned offices in the City, and therefore, is most deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga Chairman, Committee on Health and Sanitation, severally seconded by SP Members Peter M. Rodriguez, Lalaine A. Marcos, Tomas R. RESOLUTION NO. 2020-01

**A RESOLUTION APPROVING THE CITY NUTRITION ACTION PLAN 2020-2022**

WHEREAS, malnutrition remains a public health concern in the City with pre-school children (0-59 months) having the highest vulnerability due to several causes hence, priority in addressing the problem of malnutrition in the city must be given to this specified age group;

WHEREAS, the country has committed to pursue the 2030 Agenda for Sustainable Development and the Sustainable Development Goals, particularly the goal on ending hunger, achieving food security, and improving nutrition;



WHEREAS, as per DILG Memorandum Circular No. 2018-42, series of 2018, entitled "Adoption and Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022", Local Government Units (LGU's) are tasked to "ensure the formulation, or if existing, revision/updating of the local nutrition action plan to include programs, projects and activities that converge in families of the nutritionally vulnerable individuals".

WHEREAS, the Ormoc City Nutrition Committee (OCNC), as part of its duties and functions, is tasked to formulate and implement local food and nutrition policies, plans and intervention for nutrition improvement, in pursuance to above Agenda and Memorandum;

WHEREAS, after a long and thorough deliberation and study, the OCNC formulated the Ormoc City Nutrition Action Plan 2020-2022, a three (3) year plan for improving the nutritional status of zero (0) to five (5) year old pre-school children and school children of Ormoc City.

WHEREAS, it is the goal of the herein Action Plan to improve the nutritional status of pre-school children and school children through an integrated and comprehensive approach that shall serve as a guide for all concerned office in the city;

WHEREAS, for the achievement of the goal, several work plans are incorporated therein including but not limited to the following:

1. Reduction of malnutrition by Intensive Operation Timbang, monitoring of height and weight, IYCF micronutrient supplementation and Milk feeding to 2-3 year olds;
2. Establishment of GulayansaPaaralan and School based feeding program by the Department of Education - Ormoc Division;
3. Supplemental Feeding of three (3) to four (4) year olds in the Day Care Program and Livelihood Development Program and Capacity Building of Parents of malnourished children by the City Social Welfare Office;
4. Provision of Backyard Muscovy ducks for families with malnourished children, integrated community food production and Extension/Education and Livelihood Development Training by City Agriculture Office;
5. Responsible Parenthood Program and Adolescent Health Development Program by IPGDO.

WHEREAS, the herein Ormoc City Nutrition Action Plan 2020-2022, as formulated, is found to be well-integrated and comprehensive approach in the attainment of above mentioned goals for the benefit of pre-school children through the provided itemized work plans, and is geared towards the improvement and betterment of the health and lifestyle of Ormocanons;



WHEREAS, during the City Nutrition Council meeting on September 17, 2020, it was agreed to pass A RESOLUTION APPROVING THE CITY NUTRITION - ACTION PLAN 2020-2022 ;

WHEREFORE, on motion of Ms. Delia D. Corbo, member of City Nutrition Committee, seconded by Mr. Dante B. Albarico, member of City Nutrition Committee; be it



RESOLVED, FURTHER, that we commit to pursue the programs and plans herein specified and continue to identify new ones in the course of the plan's implementation.




