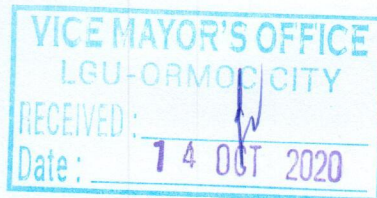
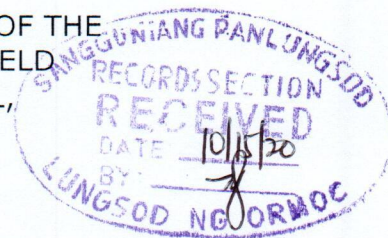

WHEREAS, the Sanggunian received two Endorsement Letters from the Office of the City Mayor dated September 23, 2020 and September 28, 2020 consecutively, respectfully requesting for passage of Resolutions granting authority to purchase one (1) Light Rescue Brand New Vehicle amounting to One Million Eight Hundred Thousand Philippine Pesos (Php1,800,000.00) and one (1) Heavy Fire Rescue Brand New Vehicle amounting to Five Million Philippine Pesos (Php5,000,000.00) for the official use of the City Disaster Risk Reduction & Management Office (CDRRMO);

WHEREAS, the requested vehicle shall be for the efficient execution of business operations and/or transactions of the CDRRMO, the primary arm that sets the direction, development, implementation and coordination of disaster risk management programs of Ormoc City;

WHEREAS, to recall, this Sanggunian approved Appropriation Ordinance No. 2020-001 otherwise known as the 2020 Annual Budget of the City of Ormoc enacted on December 10, 2019 approving therein a total budget of Ten Million Five Hundred Thousand Philippine Pesos (Php10,500,000.00) under the General Fund of the said office intended for the purchase of Light Rescue Vehicle and Heavy Fire Rescue Vehicle;



WHEREAS, the City Accountant and the City Budget Officer issued Certificates of Availability of Funds dated September 22, 2020 stating therein that the amounts of the aforesaid purchases are deemed available and are sourced from the CY 2020 General Fund of the said office, a copy of the certifications are hereto attached as Annex "A" and Annex "B" respectively, and made integral part hereof;

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;
