A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ/OIC MAYOR/ACTING MAYOR ACCEPT AND SIGN THE DEED DONATION TO BE MADE AND EXECUTED BY AND BETWEEN ATTY. ROY BERNARD C. FIEL, HEREIN REFERED TO AS DONOR, IN FAVOR OF THE CITY GOVERNMENT OF ORMOC, HEREIN REFERRED TO AS DONEE, FOR A PARCEL OF LAND SITUATED AT BARANGAY BAGONG BUHAY, THIS CITY, FOR ROAD LOT PURPOSES.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc was in receipt of a letter on its 3<sup>rd</sup> Endorsement from the Office of the City Mayor dated 6 October 2020, requesting for the passage of a resolution granting the City Mayor or his representative the authority to accept and sign the attached Deed of Donation (Deed for brevity), to be made and executed by and between Atty. Roy Bernard C. Fiel, herein referred to as "DONOR" and the Local Government Unit of Ormoc, herein referred to as the "DONEE," over a parcel of land situated at the abovementioned barangay;

WHEREAS, the DONOR, is the owner of a certain real property with improvements thereon, identified as Lot No. 5, containing an area of ONE THOUSAND SEVEN HUNDRED ELEVEN (1,711) SQUARE METERS and covered by Transfer Certificate of Title No. 44130 (TCT for brevity) of the Land Registry of Ormoc, a photocopy of the TCT is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the attached Deed clearly encapsulates that as an act of liberality, magnanimity and generosity of the DONOR, considering that he recognizes and supports the noble tasks, duties and functions of the DONEE in promoting the welfare of the community, the former voluntarily and freely transfers and conveys absolutely unto the DONEE, its successors and assigns, all of his rights, title, participation and interests over the above-described real property, a copy of the Deed is hereto attached as Annex "B" and made an integral part hereof;

WHEREAS, the DONEE accepts the donation of the above-described parcel of land and the improvements thereon and expresses its gratitude and appreciation for the support, kindness and liberality of the DONOR;

WHEREAS, as per Item 1, Section 17.1 of BIR Revenue Regulation No. 12-2018, gifts made to or for the use of the National Government or any entity created by any of its agencies which is not conducted for profit, or to any political subdivision of the said government are exempted from donor's tax;

WHEREAS, in a letter dated 16 September 2020, from the City Planning and Development Officer, it stated therein that the subject lot intended for donation is suitable for a two-lane road and will link or connect to an existing road at Puraville Subdivision and Brgy. Bagong Buhay and further recommends for the acceptance of the said donation, a copy of the said letter is hereto attached as Annex "C" and made an integral part hereof;

WHEREAS, in a communication dated 28 September 2020 from the City Legal Office, it stated therein that it finds nothing objectionable to the attached Deed, a copy of the said communication is hereto attached as Annex "D" and made an integral part hereof;

WHEREAS, this august Body believes that said donation is done in good faith, of great help to the City and not made for purposes of defrauding DONORS' creditors, having reserved for himself enough and sufficient property to meet his obligations;

WHEREAS, the said donated properties shall be considered as forming part of the City's properties for public use pursuant to the applicable provisions of the Civil Code,

WHEREAS, this Sanggunian, after thorough examination of the aforementioned request by the City Mayor finds that it is for the best interest of the City and its inhabitants and likewise advantageous to the same therefore meriting this august Body's full support and favorable action;


