A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF VILLAREAL AND THE CITY GOVERNMENT OF ORMOC, ESTABLISHMENT OF THE **DUTIES** AND RESPONSIBILITIES OF THE CITY OF ORMOC AND THE MUNICIPALITY OF VILLAREAL IN **PROVIDING** SYCHOSOCIAL SUPPORT **SERVICES** TO LATTER'S CONSTITUENTS THROUGH THE "LAMDAG ORMOC PROJECT".

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated October 5, 2020 from the Office of the City Mayor, endorsing a request for the issuance of a Resolution granting the City Mayor or Acting City Mayor the authority to sign the Memorandum of Agreement (MOA) by and between the Municipality of Villareal and the City Government of Ormoc, for the establishment of the duties and responsibilities of the City of Ormoc and the Municipality of Villareal in providing psychosocial support services to the latter's constituents through the "LAMDAG ORMOC Project", a copy of the MOA is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in a Letter dated September 16, 2020, the City Health Department informed the Office of the City Mayor that the Municipality of Villareal through Hon. Mayor Marilou P. Latorre expressed their intention and desire to adopt the City's Mental Health Program through online means to their constituents, a copy of the letter is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, in an Opinion dated October 1, 2020, the City Legal Office finds nothing legally objectionable in the said MOA and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City, a copy of the Opinion is hereto attached as "ANNEX C" and made an integral part hereof;

WHEREAS, the City Government of Ormoc was able to create a Psychosocial Support Service in accordance with the guidelines imposed by NDRRMC Memorandum No. 62 s. 2017, also known as the "National Guidelines on Mental Health and Psychosocial Support in Emergencies and Disaster Situations";

WHEREAS, a Psychosocial Support Service (PSS) named "LAMDAG ORMOC" came to light in order to help people battling from anxiety, depression, and the like to find strength and outlet to their bottled feelings and emotions during this pandemic. A "Chat and Call" service was made readily available even to people from far-flung areas coupled with a script which is universally applicable to any age, gender, and culture;

WHEREAS, the City Government of Ormoc with its capacity and capability to provide Psychosocial Support Services, has manifested its intent to provide free social support through the "LAMDAG ORMOC Project" to help areas outside Ormoc City who are experiencing the emotional impact of COVID-19 in its constituents;

WHEREAS, the Municipality of Villareal has made known its desire to undergo the Psychosocial Support Program in order to address and provide assistance to individuals in their community and who has developed moderate-severe anxiety or depression due to the pandemic;

WHEREAS, the subject MOA clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the lofty ends of the same, and this Sanggunian, upon thorough review, finds that the same is entered into for the best interests of the City and the Municipality of Villareal and their respective constituents, and therefore, is most deserving of this august Body's prompt and favorable consideration:

#### MEMORANDUM OF AGREEMENT

#### KNOWN ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement was made and entered into by and among the following Parties:

The CITY GOVERNMENT OF ORMOC, a local government unit duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at Aunubing Street, Brgy. Cogon, Ormoc City, herein represented by its CITY MAYOR, Honorable RICHARD I. GOMEZ, DPA;

-and-

The MUNICIPALITY OF VILLAREAL (herein referred to as "VILLAREAL"), under the Province of Western Samar, with office address \_\_\_\_\_\_\_ represented herein by Honorable Mayor MARILOU P. LATORRE;

## WITNESSETH: THAT

WHEREAS, LGU-ORMOC CITY established a Mental Health and Psychosocial Support Service (MHPSS) as a sub-cluster of Health Emergency Management Bureau (Hem-B) under the City Health Department; and was created to support the mental health and wellbeing of the people especially those in areas seriously hit with crisis, emergencies and disasters;

WHEREAS, a Psychosocial Support Service (PSS) named "LAMDAG ORMOC" came to light in order to help people battling from anxiety, depression and the likes to find strength and outlet to their bottled feelings and emotions during this pandemic. A "Chat and Call" service was made readily available even to people from far flung areas, coupled with a script which is universally applicable to any age, gender and culture;

WHEREAS, LGU-ORMOC CITY has implemented the set of guidelines issued by the Inter-Agency Standing Committee on Mental Health and Psychosocial Support in times of an emergency which shall enable the city to plan, establish and coordinate responses to protect and improve the people's mental health and psychosocial well-being in the midst of an emergency or disaster;

WHEREAS, LGU-ORMOC CITY was able to create a Psychosocial Support Service in accordance with the guidelines imposed by NDRRMC Memorandum No. 62 s. 2017, also known as the "NATIONAL GUIDELINES ON MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT IN EMERGENCIES AND DISASTER SITUATIONS";

WHEREAS, Section 11, Article XIII of the 1987 Constitution enunciates that the "State shall adopt an integrated and comprehensive approach to health development which shall endeavour to make essential goods, health and other social services available to all people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children. The state shall endeavour to provide free medical care to paupers."

WHEREAS, LGU-ORMOC CITY, with its capacity and capability to provide Psychosocial Support Services, has manifested its intent to provide free social support through the "LAMDAG ORMOC Project" to help areas outside Ormoc City who are experiencing the emotional impact of COVID-19 in its constituents.

WHEREAS, the Municipality of VILLAREAL has made known its desire to undergo the Psychosocial Support Program in order to address and provide assistance to individuals in

their community and who has developed moderate- severe anxiety or depression due to the pandemic;

**NOW, THEREFORE,** for and in consideration of the foregoing premises and the terms and conditions hereinafter set forth, the PARTIES have agreed as follows:

#### **DUTIES AND RESPONSIBILITIES:**

#### 1. That LGU-ORMOC CITY shall:

- a. Provide Psychosocial Support through 'LAMDAG ORMOC' to Villareal residents who need to undergo the Psychosocial Support Service;
- b. Make recommendations for referral to a higher level of care;
- c. Be free of any liability when the client develops any untoward behaviour after conduct Psychosocial Process;
- d. Assist in the monitoring process and progress of the client.
- e. Provide technical support to the program as necessary;
- f. Submit report to Villareal every Friday afternoon following the effectivity of the agreement;
- g. Handle the information acquired during the course of the project with utmost confidentiality;

#### 2. That VILLAREAL shall:

- a. Share information: Name, CP Number, and Medical Condition of Clients, and send it to email address of Lamdag Ormoc: cdm\_ul@yahoo.com;
- b. Confirm / Validate recommendations and give feedback/report seven days after the recommendation is given;
- c. Practice confidentiality at all times especially to sensitive information from the report submitted by LGU-ORMOC CITY;
- d. Regularly monitor the condition and progress of the client;
- e. Strengthen record keeping and regularly submit reports to the Provincial Health Office of Western Samar.

#### OTHER PROVISIONS:

- A. It is expressly agreed herein that all information acquired by the Parties pertinent to this arrangement shall be strictly confidential and neither Party has the authority to reveal or disclose the same to third parties without prior consent from each other. Otherwise, the guilty Party shall be held liable for damages.
- B. By mutual agreement of the parties, any provision of this contract may be changed and/or amended by way of written document by both parties. Such change or amendment shall be deemed incorporated herein.
- C. If any provision of this Agreement is, for any reason, found to be invalid or unenforceable, all other provisions of this Agreement not affected thereby shall nevertheless remain in full force and effect.
- D. This Agreement shall take effect immediately upon the signing hereof and shall be effective for a period of one (1) year and is deemed automatically renewed unless

sooner terminated by either party voluntarily or in case of violation of any terms and conditions stated in the agreement, with at least thirty (30) – day prior notice to either party.
