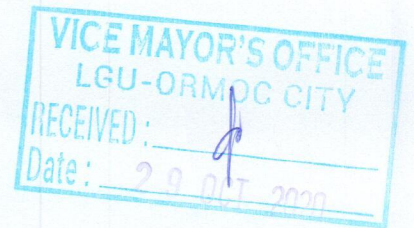

SEPARATE APPLICATIONS FOR ACCREDITATION
WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS,
TO WIT:**

**FOR PURPOSES OF RECOGNITION WITH THE LOCAL
GOVERNMENT UNIT OF ORMOC.**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in this City;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of two (2) separate applications for accreditation of the aforementioned CSOs;

WHEREAS, KFA, duly registered with the Department of Labor and Employment on 1 October 2019, is an association of farmers which seeks to develop sustainable livelihood through the conduct of activities with the aim of uplifting the economic condition of its members, to this end, they undertake rice farming from the benefits they acquired from the High Yield Technology Adaptation of the Department of Agriculture;

WHEREAS, COSE, duly registered with the Securities and Exchange Commission on 13 November 1991, is an organization implementing the project entitled Enhancing Social Accountability towards responsive and age-friendly Local Government Units in Leyte, this project aims to contribute to an improvement in the living situation of disadvantaged older people in Ormoc City;

WHEREAS, this Sanggunian, after thorough review of the aforementioned application for accreditation, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote socio-economic development among its members through the establishment of a strong linkage with the City Government in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, FURTHER, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

NOW THEREFORE, on motion of SP Member Roiland H. Villasencio, Chairman, Committee on Cooperatives and Accreditation of Non-Government Organizations, severally seconded by SP Members Nolito M. Quilang, Esteban V. Laurente, Tomas R. Serafica, Lalaine A. Marcos, Gregorio G. Yrastorza III, Joan Marbie C. Simbajon and Peter M. Rodriguez; be it

2. COALITION OF SERVICES OF ELDERLY, INC. (COSE)


