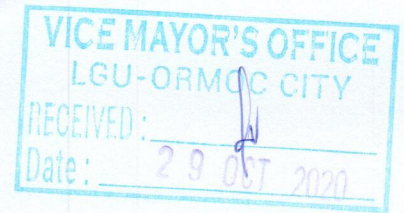
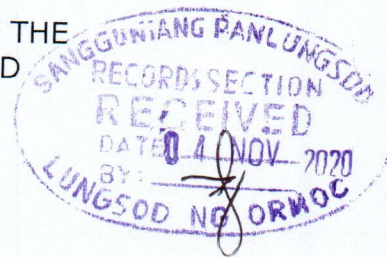

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated October 2, 2020 respectfully requesting for passage of Resolution granting authority to purchase One (1) unit Urban Search and Rescue Brand New vehicle amounting to Five Million Philippine Pesos (Php5,000,000.00) for the official use of the City Disaster Risk Reduction & Management Office;

WHEREAS, the requested vehicle shall be for the efficient execution of business operations of the City Disaster Risk Reduction & Management Office, which sets the direction, development, implementation and coordination of disaster risk management programs of Ormoc City;
