A RESOLUTION AUTHORIZING THE REIMBURSEMENT OF THE FOREIGN TRAVEL OF SP MEMBER LALAINE A. MARCOS TO TAIPEI, TAIWAN AS PER TRAVEL ORDER NO. 2019-514 DATED OCTOBER 10, 2019, IN THE AMOUNT OF ONE HUNDRED TWENTY-FIVE THOUSAND NINE HUNDRED SEVENTY-SIX PHILIPPINE PESOS AND TWENTY-THREE CENTS (PHP125,976.23) TO BE CHARGED AS PRIOR YEAR'S OBLIGATION AGAINST THE CURRENT YEAR APPROPRIATION UNDER THE OFFICE OF THE CITY MAYOR.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated September 18, 2020 from the City Mayor's Office requesting for an issuance of resolution authorizing the reimbursement of the foreign travel of SP Member Lalaine A. Marcos to Taipei, Taiwan as per Travel Order No. 2019-514 dated October 10, 2019, in the amount of One Hundred Twenty-Five Thousand Nine Hundred Seventy-Six Philippines Pesos and Twenty Three Cents (Php125,976.23) to be charged as Prior Year's Obligation against the Current Year's Appropriation under the Office of the City Mayor;

WHEREAS, the Department of Interior and Local Government (DILG) issued a letter last December 4, 2019 approving aforesaid travel in compliance with DILG Memo Circular No. 2019-83, copy of the letter is attached herein as Annex "A";

WHEREAS, COA Circular No. 2012-004 mandates the liquidation of foreign travel within 60 days after the return to the Philippines;

WHEREAS, as per the attached Justification Letter of SP Member Lalaine A. Marcos, the reimbursement was not processed within the time required due to internal staffing issues wherein the personnel-in-charge of the liquidation documents failed to forward said documents to the authorizing office;

WHEREAS, the City Accountant stated in her comments/recommendation on the request of the City Mayor that, inter alia, the resort to charge the travel cost to CY 2020 funds under the account Travelling Expense-Foreign is subject to the availability of funds and submission of pertinent documents required for the approval of the reimbursement, said comments is herein attached as Annex "B" and made integral part hereof;

WHEREAS, the Local Finance Committee issued a Certificate of Availability of Funds dated September 17, 2020 stating therein that the amount is deemed available chargeable against the current year appropriation under the Office of the City Mayor account for Foreign Travel Expenses, a copy of the certification is hereto attached as Annex "C" and made integral part hereof;

WHEREAS, among the required documents to process the reimbursement is a Sangguniang Panlungsod Resolution approving the same;

WHEREAS, this august Body found the request to be justified and reasonable and is deemed not contrary to existing accounting and auditing laws, rules and regulations;



COMMENTS/RECOMMENDATIONS: Following are this level's comments with respect to the subject-caption:

- 1. The subject-captioned foreign travel happened in CY2019, payment/reimbursement for the travel expenses can no longer be charged to CY2019 funds for the following reasons:0
 - a. Documents for the reimbursement was not submitted/obligated in 2019;
 - b. The 2019 books of accounts of the City has already been long closed; and
 - c. CY2019 surplus is already fully appropriated for prioritized purposes, without excess;
- 2. The resort to charge the costs to CY2020 funds under the account Travelling Expenses-Foreign is, however, subject to availability of funds and the existence of said account in the corresponding MOOS of your office, and further subject to the submission of the following documents:
 - a. Sangguniang Panglungsod Resolution allowing the said expense to be charged to current appropriation (CY2020);
 - b. Narrative Report of Travel as expressly required in the Amended Guidelines on the Foreign Travel per DLG Memo Circular No. 2019-83 dtd. May 29, 2019 (Sec. 8.4)
 - c. Written justification/explanation for the delay in the processing of the payment/reimbursement (around 5 months from the date of actual travel); it must be noted, as per COA Training Handbook on Government Expenditures, reimbursement of foreign travel expenses (liquidation of cash advances) should be made within sixty (60) days after the return to the Philippines
 - d. All other supporting documents to substantially serve as basis for allowing payment (i.e. DILG Authority to travel, Itinerary of Travel, basis for rate conversion, etc.); (Refer to attached DILG Memo Circular No. 2019-83 dtd. May 29, 2019)
- 3. Lastly, as may be applicable, please ensure observance of the limitations set forth under Section 4.3 of DBM National Budget Circular No. 580 dated April 22, 2020, (Adoption of Economy Measures in the Government Due to the Emergency Health Situation), on the discontinuance of certain projects/activities (Sec. 4.3.1.3) within the duration of the declaration of a State of Emergency.
