WHEREAS, this Sanggunian received an indorsement from the City Mayor, dated October 19, 2020, requesting for the issuance of a resolution granting the City Mayor or his representative, the authority to sign the contract of work to be entered into, by and between the City Government of Ormoc and Maricris L. Casas. Photocopy of the contract is hereto attached as "ANNEX A" and made integral part hereof;

WHEREAS, pursuant to Section 10 of Ordinance No. 02, series of 2019, it provides that "xxxxxx - The Center shall hire trainors subject to the qualifications, duties and responsibilities xxxx to be governed by a yearly renewable contract subject to the terms for renewal to be determined by the Board. xxxxxxx";

WHEREAS, the signing of contract of work signifies the party's commitment to continually uphold quality technical and vocational education that will benefit the people of the City of Ormoc especially those who need to acquire or improve their vocational and technical skills;

WHEREAS, the said contract of work clearly and plainly encapsulates the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations towards the attainment of the ends of the same;

WHEREAS, Section16 of the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local governments units shall ensure and support, among other things, the preservation and enrichment of culture, XXXXXXXXX support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitant";

WHEREAS, this Sanggunian finds it more efficient and more convenient to pass an omnibus resolution authorizing the City Mayor to sign all work contracts with trainers or would be trainers of Ormoc TESDC to ensure smooth and unhampered implementation of the vocational and technical skills training programs;

WHEREAS, this Sanggunian, upon thorough review, finds that the said contracts are not contrary to law, public policy, public morals and existing contracts, and the aim is important and beneficial to the City of Ormoc as it contributes to the city's human development efforts especially in making ormocanon workers competitive thereby improving their chances for better job opportunities and therefore is most deserving of this august body's prompt and favorable consideration;

CONTRACT OF WORK

FOR SIX (6) MONTHS

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF WORK made and entered into by and between:

The CITY GOVERNMENT OF ORMOC, a city corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at Ormoc City, Leyte, represented by its CITY MAYOR, HON. RICHARD I. GOMEZ, herein referred to as the "ORMOC TESDC"

WITHNESSETH: That - - -

WHEREAS, the ORMOC TESDC is a Tech-Voc training Center with an end view of helping the less fortunate and underprivileged constituents of the city;

WHEREAS, the WORKER needs the services of a qualified and competent worker to be able to accomplish its mission and vision;

WHEREAS the WORKER manifests and guarantees that he possesses the requisite qualities and competencies needed by the ORMOC TESDC in the conduct of its manpower training, research and development;

WHEREAS, the parties hereto desire to enter into this agreement to define and set forth the terms and conditions of the employment of the worker by the ORMOC TESDC:

NOW THEREFORE, the parties hereby agree as follows:

- 1. The TERM OF WORK to be accomplished will be terminated on December 31, 2020 pursuant to the Board Resolution No. 006 Series of 2020.
- The remuneration to be paid to the WORKER by ORMOC TESDC is based on the approved Regional Consolidated Qualification Map under Training for Works Scholarship Program (TWSP)/Rice Extension Services Program (RESP)
- 3. The worker shall have the following duties and responsibilities:

TRAINER

 a. Conduct classes on technical subjects set forth at the training center for basic, common and sore competencies;

- Install and maintain the necessary components of Competency- Based Training Delivery System;
- Prepare updated session plan/syllabus for the trainees. Such session plans should be submitted to the Center Administrator before the classes started;
- d. Utilize effective teaching methods and techniques to maximize learning, considering factors such as trainees' level of competence, lesson context, class hours:
- e. Conduct Institutional Assessment prior subjecting the irainees to National Assessment;
- f. Monitor student's progress in learning through the use of evaluation tools and other methods of appraisal such as Prescribed Progress Chart to facilitate the desired learning of students;
- g. Ensure workshops are well-equipped, functional and maintained according to the curriculum requirements. All equipment, tools, materials and supplies are complete, secure, and in order during and after every work session.
- h. Maintain and implement harmonious interpersonal relationship with and among superiors, co-workers and trainees;
- i. Perform other related duties that may be assigned by the CENTER ADMINISTRATOR.
- 4. The parties hereby adopt the no-work no-pay principle, which means that if worker is absent and not working for the ORMOC TESDC, he/she is not entitles to be paid his wage;
- 5. The WORKER will be working for EIGHT (8) HOURS daily, subject to break time during snack time designated by the ORMOC TESDC;
- When the employee sees the need for OT, he/she shall first secure authorization from the Administrator of his/her department. Failure to obtain the said authorization shall not entitle him/her to overtime pay.
- 7. The WORKER shall perform the duties and responsibilities that his/ her position or job necessarily entails, as may be contained in his/her job description or as may be reasonably assigned to him/her by the ORMOC TESDC from time to time. The WORKER is obliged to perform his duties loyally, independently and industriously to help meet the goals and objectives of the ORMOC TESDC and is expected to carry out these responsibilities to the best of his knowledge and abilities in order to protect and advance the interests of the ORMOC TESDC.
- 8. The WORKER shall observe and comply with all company rules and regulations written or otherwise.
- Any violation by the WORKER of the terms and conditions this contract shall be ground for the termination of this contract.
- 10. The WORKER has read and fully understood the terms and conditions hereof and accepts the same;
