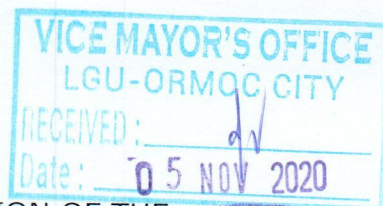
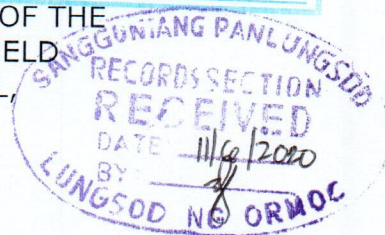

**A RESOLUTION APPROVING AND AUTHORIZING THE

WHEREAS, the Sanggunian received an endorsement letter from the Office of the City Mayor dated October 22, 2020 respectfully requesting for passage of Resolution granting authority to purchase One (1) unit Service Vehicle amounting to Nine Hundred Ninety-Nine Thousand Five Hundred Sixty-One Philippine Pesos (Php 999,561.00) for the official use of the City Social Welfare Department;

WHEREAS, the requested vehicle shall be for the efficient execution of business operations of the City Social Welfare Department which implements programs, projects and services that will alleviate and empower disadvantaged individuals, families and communities;

WHEREAS, the City Accountant and the City Budget Officer issued Certificate of Availability of Funds dated October 19, 2020 stating therein that the amount of the aforesaid purchase is deemed available and are sourced from the CY 2020 General Fund Motor Vehicles of the said office, a copy of the certification is hereto attached as Annex "A" and made integral part hereof;


