RESOLUTION NO. 2020-387

**A RESOLUTION URGING THE PHILIPPINE STATISTICS
AUTHORITY (PSA) TO ESTABLISH
A CIVIL REGISTRY SYSTEM (CRS) CENTER IN ORMOC
CITY DUE TO THE PRESENT AND FUTURE DEMANDS
OF THE PUBLIC.**

WHEREAS, it has come to the attention of the undersigned Chairman of the Committee on Good Government and Oversight about the clamor of the people to have an extension office of the PSA in Ormoc City because the existing registered office of the PSA where people can get their authenticated copy of the Birth Certificates and the Civil Registry documents is located in Tacloban City which entails, long and expensive travel just to get their needed document;

WHEREAS, the clamor also includes higher fee collected by the City Civil Registrar should one decide to request for an authenticated copy of their "Certificate of Live Births" and other Civil Registry documents, at the Office of Civil Registry in Ormoc City;

WHEREAS, on February 11, 2020 where the Civil Registrar was subjected to the Question Hour portion during the regular session of the Sanggunian, he admitted to ask the amount of Php 200.00 pesos from those who make their request at their office for an authenticated copy of Certificate of Live Birth instead of Php 155.00 pesos because it will serve as buffer to those who don't pay;

WHEREAS, the PSA (NSO) has an existing Program for a Batch Request Query System (BREQS) which is facilitated by the City/Municipal Civil Registrar whereby any request for authenticated copies of Civil Registry documents can be made at the appropriate Municipal/City Civil Registry Office for an appropriate fee and said request shall be forwarded to the PSA Regional Office by the Civil Registrar concerned per batch, either once a week or once in every two weeks and the fee is collected by the City/Municipal Treasurer to be remitted to the account of the PSA with certain commission for the LGU depending on the MOA executed by the PSA and LGU;

WHEREAS, the PSA has a better program now called CRS Center whereby the PSA may establish CRS (Civil Registry Service) Center to a Municipality or City so that people from that City or neighboring municipalities may avail of the services of the PSA directly to the CRS Center instead of going through the hassle in a usual far away Regional Office of the PSA;

WHEREAS, the present Regional Director of the PSA said that they identified Ormoc City as one of the recipients of CRS Center of the PSA but until now said CRS Center have not been realized;

WHEREFORE, on motion of SP Member Jasper M. Lucero, Chairman, Committee on Good Government, severally seconded by SP Members Eusebio Gerardo S. Penserga, Peter M. Rodriguez, Esteban V. Laurente, Tomas R. Serafica, Vincent L. Rama, Joan Marbie C. Simbajon, Gregorio G. Yrastorza III and Roiland H. Villasencio; be it


