A RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 IN THE TOTAL AMOUNT OF THREE HUNDRED FORTY-SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PHILIPPINE PESOS (PHP 347,760,000.00) FOR THE CY 2021 OF THE CITY OF ORMOC THEREBY ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 7, SERIES OF 2020.

WHEREAS, the Fifteenth Sangguniang Panlungsod ng Ormoc received an Endorsement dated November 25, 2020 from the City Mayor Richard I. Gomez forwarding the City Development Council (CDC) Resolution No. 7, SERIES OF 2020, entitled "A RESOLUTION APPROVING THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 AND REQUESTING THE HONORABLE 15th SANGGUNIANG PANLUNGSOD FOR THE ADOPTION OF THE SAME." Copy of said Resolution together with its attachments is hereto attached and made an integral part hereof;

WHEREAS, the Supplemental AIP involves a total investment of **Three Hundred Forty-Seven Million Seven Hundred Sixty Thousand Philippine Pesos (PHP347,760,000.00)** for the priority projects, programs and activities to be implemented which are expected to spur economic growth and development in the City of Ormoc;

WHEREAS, after thorough discussion, the City Development Council (CDC) believes that the identified projects and programs are vital to the continuous development of the city, necessary, and in accordance to the present needs of the Ormocanon community;

WHEREAS, this Sanggunian considers the proposed Supplemental AIP to be in line with the administration's thrust for the continued improvement and development of the city along with the vision of providing good quality of life to the Ormocanons through the delivery of efficient public service, and hence, it is deemed appropriate that the matter be accorded favorable action;


