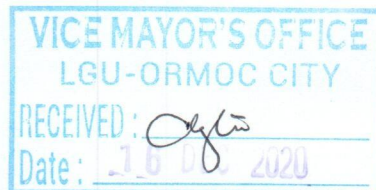

**A RESOLUTION APPROVING AND AUTHORIZING THE
PURCHASE OF ONE (1) UNIT BRAND NEW SERVICE
VEHICLE FOR THE CITY VETERINARY OFFICE**

WHEREAS, the Sanggunian was in receipt of an Endorsement Letter from the Office of the City Mayor dated December 12, 2020 respectfully endorsing the request of the City Veterinary Office for the passage of a resolution approving and granting them authority to purchase One (1) Unit Brand new service vehicle for the total amount of One Million Five Hundred Ninety-Eight Thousand Philippine Pesos (Php 1,598,000.00);

WHEREAS, the City Veterinary Office manifested its purpose for the request which is esteemed from the need to replace its old and dilapidated vehicle currently being utilized by their office thus promoting safety during their operation as well as to provide better mobility in the conduct of their office duty;

WHEREAS, the City Treasurer and City Accountant issued a Certificate of Availability of Funds dated November 17, 2020 indicating therein that the amount of One Million Six Hundred Thousand Philippine Pesos (Php 1,600,000.00) is deemed available and is sourced from the CY 2020 General Fund and CY 2019 Unexpended Capital Outlay for Motor Vehicle of the aforementioned office, a copy of the certification is attached as Annex "A" and made an integral part hereof

WHEREAS, this Sanggunian finds that the request is meritorious, reasonable and necessary to facilitate the effectiveness and efficiency of the requesting office and improve their capability to accomplish deliverables satisfactorily which will ultimately redound to the benefit of the public, and not contrary to law, public policy and morals, and therefore, is most deserving of this august Body's prompt and full support;
