**A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT  
OF ORMOC (LGU), IN ACCORDANCE WITH THE  
PROVISIONS OF ORDINANCE NO. 009 DATED OCTOBER  
16, 2014 OF THE LEYECO V EMPLOYEES  
MULTIPURPOSE COOPERATIVE (LEVEMCO).**

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in this City;

WHEREAS, Section 2.1 of the same Ordinance provides among others that an organization may still be accredited after the prescribed sixty - day (60) period within which applications for accreditation for membership in the Local Special Bodies by any organization shall be accepted, for purposes other than representation to the Local Special Bodies;

WHEREAS, this august Body is in receipt of an application for accreditation of the aforementioned CSO;

WHEREAS, LEVEMCO, duly registered with the Cooperative Development Authority is a cooperative which seeks to promote and advance the economic, social status of its members through activities such as but not limited to, lending operation, motorpool and customer care and line clearing services, and LEYECO Payment Center;


