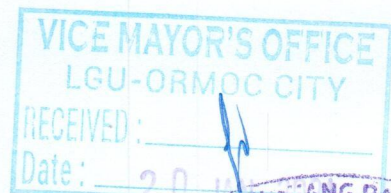

**RESOLUTION NO. 2021-017**

**A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) TO BE ENTERED BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC, HEREIN REFERRED TO AS DONOR AND THE PHILIPPINE NATIONAL POLICE-ORMOC CITY POLICE OFFICE, HEREIN REFERRED TO AS DONEE, FOR THE ITEMS LISTED IN THE SAID DEED OF DONATION TO BE USED SPECIFICALLY BY THE SPECIAL WEAPONS AND TACTICS (SWAT) TEAM.**

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated January 11, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor to accept and sign the Deed of Donation (DOD) to be entered by and between the Local Government Unit of Ormoc, herein referred to as donor and the Philippine National Police-Ormoc City Police Office, herein referred to as donee, for the items listed in the said Deed of Donation to be used specifically by the Special Weapons And Tactics (SWAT) TEAM, a copy of the DOD is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated January 11, 2021, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, the donor recognizes and supports the noble task of the donee in promoting peace and order and ensuring the safety and security of the residents and the people of Ormoc;



WHEREAS, the donor desires to assist the donee and give further impetus to the performance by the latter of its mandate which includes but is not limited to hostage crisis, hostage negotiations, and counter-terrorism in the Ormoc City through its Special Weapons and Tactics (SWAT) Team;

WHEREAS, this Sanggunian, after thorough examination of the aforementioned Deed of Donation, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, facilitates the ongoing developmental progress of the City and henceforth, deserving of this august Body's prompt and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Gregorio G. Yrastorza III, Peter M. Rodriguez, Esteban V. Laurente, Roiland H. Villasencio, Jasper M. Lucero, Lalaine A. Marcos and Vincent L. Rama, be it


ADOPTED, January 19, 2021.

KNOW ALL MEN BY THESE PRESENTS:

This DEED OF DONATION, made and executed by:

WHEREAS, the DONOR desires to assist the DONEE and give further impetus to the performance by the latter of its mandate which includes but is not limited to hostage crisis, hostage negotiations and counter- terrorism in the Ormoc City through its Special Weapons and Tactic (SWAT) Team;

NOW, THEREFORE, for and in consideration of the foregoing premises and due to the magnanimity of the DONOR, the latter hereby transfers and conveys unto the DONEE, by way of DONATION, the equipment as enumerated above, subject to the conditions that:

- The DONEE shall, at its own expense, maintain the donated equipment and exercise all measures to ensure that said equipment are in functioning condition at all times;
- Observe all legal provisions relative to the use, ownership and possession of the donated items with the proper agency(ies)/ department(s) and secure the required permit(s) or license(s) pursuant to applicable laws and issuances;
- Devote the use of the equipment only for and within the City of Ormoc;
- Free the DONOR from any and all liability that may arise from the use and possession of the said firearms whether by the DONEE's authorized personnel or otherwise;

In the event that the conditions of the donation, as contained herein, are not complied with by the DONEE within thirty (30) days after the latter's failure to comply with the same is brought to its attention, this donation shall be automatically revoked and rendered ineffective and the DONOR shall regain ownership over the equipment and shall have the right to recover possession of the same.

The DONEE hereby accepts the donation of the equipment as listed herein together with the conditions herein imposed, and hereby expresses its gratitude and appreciation for the support, kindness and liberality of the DONOR.
