A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) TO BE ENTERED BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC, HEREIN REFERRED TO AS DONOR AND THE PHILIPPINE NATIONAL POLICE-ORMOC CITY POLICE OFFICE, HEREIN REFERRED TO AS DONEE, FOR 1 LOT KENWOOD NXR-710.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated January 6, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor to accept and sign the Deed of Donation (DOD) to be entered by and between the Local Government Unit of Ormoc, herein referred to as donor and the Philippine National Police-Ormoc City Police Office, herein referred to as donee, for 1 lot KENWOOD NXR-710, a copy of the DOD is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated January 5, 2021, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;

WHEREAS, in a Communication dated December 22, 2020, the Ormoc City Disaster and Risk Reduction Management Office (OCDRRMO) informed the Office of the City Mayor that former has finished the installation and commissioning of 2-Way Digital Interface Very High Frequency (VHF) Radio Repeater for the PNP-OCPO, a copy of the Communication is hereto attached as "ANNEX B" and made an integral part hereof;

WHEREAS, the donor is the absolute owner of 1 lot Kenwood NXR-710 in the amount of Nine Hundred Ninety Thousand Philippine Pesos (Php 990,000.00);

WHEREAS, in consideration of the desire to improve coordination through reliable communication in times of emergency, which can support and/or serve as support in the communication capability of both parties for responding to any security, emergency, and disaster response;

WHEREAS, this Sanggunian, after thorough examination aforementioned Deed of Donation, finds that: the same is not contrary to law, existing contract, public policy, customs and morals; is reasonable and in order; the same is entered into for the best interests of the City; and, finally, that the granting of the authority to sign and accept the Deed of Donation, among other lawful purposes, facilitates the ongoing developmental progress of the City and henceforth, deserving of this august Body's prompt and favorable consideration;



4. The DONEE shall handle, care for, and assume all maintenance, repair and equipment license renewal expenses for the donated communication equipment by the DONOR.

- 5. The DONEE shall maintain an inventory of the equipment and registry of accountable officers having custody of each piece of equipment, who shall maintain such properties for use within the jurisdiction of Ormoc City, confice laws, public inventory shall be furnished to the CDRRM annually.
- 6. In case of reassignment of any accountable officer, he/sheasthall turn the equipment over to the PNP-OCPO in optimum condition, the latter shall immediately update record on accountable officer/s for subject equipment.
- 7. The DONEE will aid the DONOR in responding violence related emergencies.
- 8. The DONEE shall not modify the configuration of the Radio unless CDRRMO issued a written certification to the DONEE authorizing the said organization.
- 9. The DONEE shall commit to the sustained operations of the Philippine National Police and the Radio equipment donated by the DONOR exclusively for the operations of the Philippine National Police.
- 10. If the DONEE commits a breach of the conditions provided in the sections above, the DONOR or its assigns, successors-interest, may take such action, including the revocation of the donation, in order to protect its interest.
- 11. Upon the revocation of the donation, the DONEE shall forthwith return to the DONOR within 30 days the donated items above enumerated without prejudice to indemnification for actual damages.
- 12. The parties hereto mutually agree that this donation in favor of the DONEE does not in any way bind the DONOR to grant future requests for donation by the DONEE.

NOW THEREFORE, for and in consideration of the performance and observance of the above obligations, the said DONOR hereby cedes, transfers and conveys by way of Donation, unto said DONEE, who hereby ACCEPTS, the personal property above-described free from all liens and encumbrances.
