A RESOLUTION FURTHER AMENDING SECTION 1, RULE VIII, ENTITIED: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD", AS AMENDED.

WHEREAS, this Sanggunian passed Sangguniang Panlungsod (SP) Resolution 2020-275 on September 8, 2020 entitled: "A RESOLUTION AMENDING SECTION 1, RULE VIII ENTITLED: A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15TH SANGGUNIANG PANLUNGSOD";

WHEREAS, Section 1, Rule VIII of the approved Internal Rules of Procedure of this Sanggunian reads as follows:

"Section 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Tuesday at exactly 9:00 o'clock in the morning. The session can be conducted through a video conference which shall be attended in the alternative by Teams I, II, and III, with one (1) Team assigned to be physically present in each session according to a schedule agreed on by the Sanggunian, to wit:

The City Vice-Mayor or the Presiding Officer shall be present during the Session. He shall appoint a Presiding Officer "Pro Tempore" among the SP Members physically present in the Session Hall, when needed;"

WHEREAS, in view of the continuing rise of confirmed cases of the Corona Virus Disease-2019 (COVID-19), LGUs are enjoined to practice social distancing and observe other health protocols to effectively curtail the spread of COVID-19;

WHEREAS, the 15th Sangguniang Panlungsod deems it proper to further amend Section 1 Rule VIII of the Internal Rules of Procedure to minimize close contact between and among the Members of the Sangguniang Panlungsod, its staff, guests, and the attending public;

WHEREAS, upon deliberation and consideration, this august Body is amenable to use video conferencing as an alternative and be virtually present during the Regular and Special Sessions and Pre-Session Caucus and still effectively render public service without diminishing the plenary powers of this Sanggunian;

WHEREAS, in view of the foregoing, there is a need to further amend Section 1 Rule VIII, which shall now read as follows:

"Section 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Tuesday at exactly 9:00 o'clock in the morning. The session can be conducted through a video conference which shall be attended in the alternative by Teams I and II on each session according to a schedule agreed on by the Sanggunian, to wit:

WHEREAS, for the purpose of putting into effect some of the provisions of the foregoing amendment, the application of pars. 2 and 4, Section 1 entitled, "PRESIDING OFFICER "PRO-TEMPOPORE" and "ASSISTANT MAJORITY FLOOR LEADER", respectively, of this Sanggunian's Internal Rules of Procedure, shall be temporarily suspended;

Pongos, Jr., Chairman, Committee on Internal Rules and Procedure and Legislative Tracking, severally seconded by SP Members Tomas R. Serafica, Peter M. Rodriguez, Gregorio G. Yrastorza III, Esteban V. Laurente, Roiland H. Villasencio, Lalaine A. Marcos, Vincent L. Rama, Jasper M. Lucero and Joan Marbie C. Simbajon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION FURTHER AMENDING SECTION 1, RULE VIII, ENTITLED: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 15^{TH} SANGGUNIANG PANLUNGSOD", AS AMENDED;
