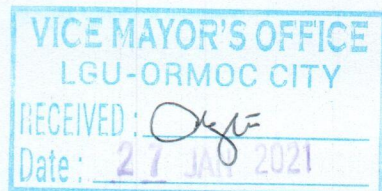

**RESOLUTION NO. 2021-028**

**A RESOLUTION INTERPOSING NO OBJECTION TO THE MISCELLANEOUS LEASE AGREEMENT (MLA No. 083738-21) APPLICATION OF MAC BUILDERS IN BARANGAY LINAO, ORMOC CITY WITH CONDITIONALITIES, TO INCLUDE THE REQUIRED ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) AND THE AGREEMENTS REACHED WITH THE BARANGAY FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL (BFARMC)**

WHEREAS, the Local Government Code (RA 7160) mandates for every Local Government Unit to exercise its inherent powers, as well as share with the national government the responsibility in the management and maintenance of ecological balance in its respective territorial jurisdiction;

WHEREAS, a letter dated September 28, 2020 from the City's Environment and Natural Resources Office (ENRO) addressed to City Mayor Richard I. Gomez and SP Member Lalaine A. Marcos requesting for a committee meeting appointment with the Committee on Environment, Natural Resources and Energy Conservation to discuss a "letter of Engineer Manuel A. Chua, dated June 17, 2020, requesting the LGU-Ormoc to issue a certification interposing no objection to the foreshore lease agreement application they submitted at the Department of Environment and Natural Resources (DENR)" and which the Office of the Vice Mayor of Ormoc City respectfully endorsed to SP Member Lalaine Marcos, as the Chairman of the Committee on Environment, Natural Resources, and Energy Conservation in an Endorsement Letter dated October 6, 2020;

WHEREAS, the said Resolution is an important Requirement set by the Community Environment and Natural Resources Office (CENRO) in the approval of the Foreshore Lease Agreement (FLA) application of Mac Builders;

WHEREAS, perusal of pertinent documents, and the manifestation of Engr. Leo Macabeo, shows that the subject of the application is a Miscellaneous Lease Agreement (MLA No. 083738-21);

WHEREAS, MAC Builders (proponent) has secured Certifications Interposing No Objection to their FLA Application from the DPWH Leyte 4<sup>th</sup> Engineering District and from the Philippine Ports Authority, as required of them by CENRO; as well as a Certification from LGU-Ormoc's City Planning and Development Office (CPDO) that no future improvements are planned on subject area, all subject to conditions cited therein;

WHEREAS, the City's Environment and Natural Resources Office (ENRO), following a thorough inspection of the project under the subject Application, found, through a letter-inquiry with the Environmental Management Bureau (EMB) that the project has an actual reclamation and would need an Environment Compliance Certificate (ECC) to proceed;

WHEREAS, Barangay Fisheries and Aquatic Resources Management Council (BFARMC) of Brgy. Linao manifested, during the Committee Meeting dated October 15, 2020, its opposition to the MLA Application of MAC Builders over concerns on marine life;


WHEREAS, following the December 4, 2020 dialogue between Barangay Linao, Ormoc City fisherfolks and MAC Builders, the BFARMC through its Chairman Diosdado Arcillas, withdrew its opposition, subject to the agreements among the BFARMC, proponent and the City Agriculture Office-Fisheries Division. Minutes to subject dialogue enumerating the agreements averred is hereto attached as Annex "A" and is made integral part hereof;

WHEREAS, during the January 14, 2021 committee meeting of the Committee on Environment, Natural Resources and Energy Conservation, the Committee, through SP Member Lalaine A. Marcos, found that conditions agreed upon by the proponent, concerned BFARMC and LGU offices, conditions imposed upon by various government agencies granting clearance for subject application, and compliance to securing the requisite Environmental Compliance Certificate (ECC), are sufficient safeguards to ensure protection of the marine environment affected by the subject application;

WHEREFORE, on motion of SP Member Lalaine Marcos, Chairman, Committee on Environment, Natural Resources, and Energy Conservation, severally seconded by SP Members Esteban V. Laurente, Gregorio G. Yrastorza, III, Joan Marbie C. Simbajon, Jasper M. Lucero and Roiland H. Villasencio; be it

RESOLVED, AS IT IS HEREBY RESOLVED, that a RESOLUTION INTERPOSING NO OBJECTION TO THE MISCELLANEOUS LEASE AGREEMENT (MLA No. 083738-21) APPLICATION OF MAC BUILDERS IN BARANGAY LINAO, ORMOC CITY WITH CONDITIONALITIES, TO INCLUDE THE REQUIRED ENVIRONMENTAL COMPLIANCE CERTIFICATE (ECC) AND THE AGREEMENTS REACHED WITH THE BARANGAY FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL (BFARMC);



## 89"MINUTES OF THE DIALOGUE BETWEEN BRGY. LINAO FISHERFOLKS AND MACBUILDERS COMPANY HELD AT BRGY. LINAO SESSION HALL, ON DECEMBER 4, 2020"

The dialogue came to an order at 1:46 in the afternoon presided by Mr. Shem B. San Jose from Animal Production and Fisheries Division.

A short prayer was led by Mr. Diosdado Arcillas, Barangay Fisheries and Aquatic Resources Council (BFARMC) Chairman in Brgy. Linao.

**SUBJECT: DIALOGUE BETWEEN BRGY. LINAO FISHERFOLKS AND MACBUILDER COMPANY**

### SUMMARY OF THE MINUTES OF THE MEETING ON DECEMBER 4, 2020

On December 4, 2020, a meeting was held by MAC Builders discussion invitation regarding concerns amongst the barangay fisherfolk. The City Agriculture Office - Animal Production and Fisheries Division assisted and acted as mediators during the meeting. The purpose of the meeting was to finalize and resolve any issues and concerns that the barangay fisherfolk may have towards the private port application in Brgy. Linao, Ormoc City. Mr. Diosdado Arcillas, BFARMC Chairman, led the discussion regarding concerns raised by the barangay fisherfolk. The discussion lasted for three (3) hours before concluding to an agreement.

#### Following agreement that was finalized:

1. Provide Social Responsibility during calamities to local residence affected.
2. Coordinate with CAO-APFD when witnessing illegal fishing activities and environmental concerns.
3. Support to the establishment of Brgy. Linao Fish Sanctuary by providing materials for artificial reef, maintenance, and monitoring.
4. Provide beach access if needed to the barangay fisherfolk.
5. Commitment to allocate portion of the jetty port to allow fishing boat safety docking during bad weather conditions following port safe protocols.
6. Provide priority part-time employment to Brgy. Linao fisherfolk for port assistant (meets qualification).
7. Commitment to take full responsibility of damages the port may incur towards the established Brgy. Linao fish sanctuary and the coastal environment.
