# RESOLUTION NO. 2021-032

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ OR THE ACTING CITY MAYOR TO ACCEPT AND SIGN THE DEED OF DONATION (DOD) TO BE ENTERED BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC, HEREIN REFERRED TO AS DONOR AND THE PHILIPPINE NATIONAL POLICE-ORMOC CITY POLICE OFFICE, HEREIN REFERRED TO AS DONEE, FOR COMPUTER EQUIPMENTS.

WHEREAS, this Fifteenth Sangguniang Panlungsod was in receipt of an Indorsement dated January 18, 2021 from the Office of the City Mayor, endorsing a request for the issuance of an authority for the City Mayor to accept and sign the Deed of Donation (DOD) to be entered by and between the Local Government Unit of Ormoc, herein referred to as donor and the Philippine National Police-Ormoc City Police Office, herein referred to as donee, for computer equipments. Further, requesting that this matter be treated as EXTREMELY URGENT, a copy of the DOD is hereto attached as "ANNEX A" and made an integral part hereof;

WHEREAS, in an Annotation dated January 14, 2021, the City Legal Office finds nothing legally objectionable in the said DOD and that the same is not contrary to law, morals, public order, or public policy much less detrimental to the best interest of Ormoc City;
